Josh- You can give us a pledge and we can get you more information Dean how much was the estimate?

Dean- We need about 1100\$

Josh- Moving on to Budget and Audit.... Lisa do we have a budget in-place

Lisa- No I have ask multiple times verbally to get together for the budget with no response

Josh- we can get other quotes

Vic- Mary has a sister that is a CPA I can ask her

Mary- Yes but it has been said that since she owns property out here she can't

Josh- yes that would not be considered because she owns property here

Vic- well yes but she doesn't live here. Some one some where isn't going to be happy with anything you do. So just do it and get it over with use her.

Lynn O- (inaudible no microphone) something about it doesn't matter that is her license and she can decide for herself. Your going to get 12 different opinions from 12 different people. It doesn't matter what you think or what I think. We need to be legal.

Tony O- First the web page looks great second I am glad to hear that Joy and Vera road is being worked on that road hasn't been touched in 15yrs one of the reasons it hasn't been touched Joy was on the board they ask for the road not to be touched because they were on the board and they didn't want it to look like favoritism. Question for you Lisa. How much have we collected this year so far for 2024 assessments and what have we collected in the past at this time? Just roughly we are not going to hold you to.

My question is what is the board going to do to bring in 90% of it. Because to be honest with you I am not interested in paying for the people that don't pay.

Lisa- I will get you the numbers for each year of what was collected as of March 1st. Second I have started a collection procedure. I set up payment arrangements and if they do not come pay on the date they promised to pay I wait a couple of extra days and I call them. I would say from last year 80% of the people that had payment arrangements payed them off in full I would call that a success.

Lynn O- Yes that is a success and thank you for that I thank your doing a great job. I hope other can see that and appreciate what you are doing.
