Initially we will focus our investment in the property sector i.e. student accommodation and inner-city residential accommodation and the revival of township grocery stores forced to close by malls and big white owned grocery retailers.

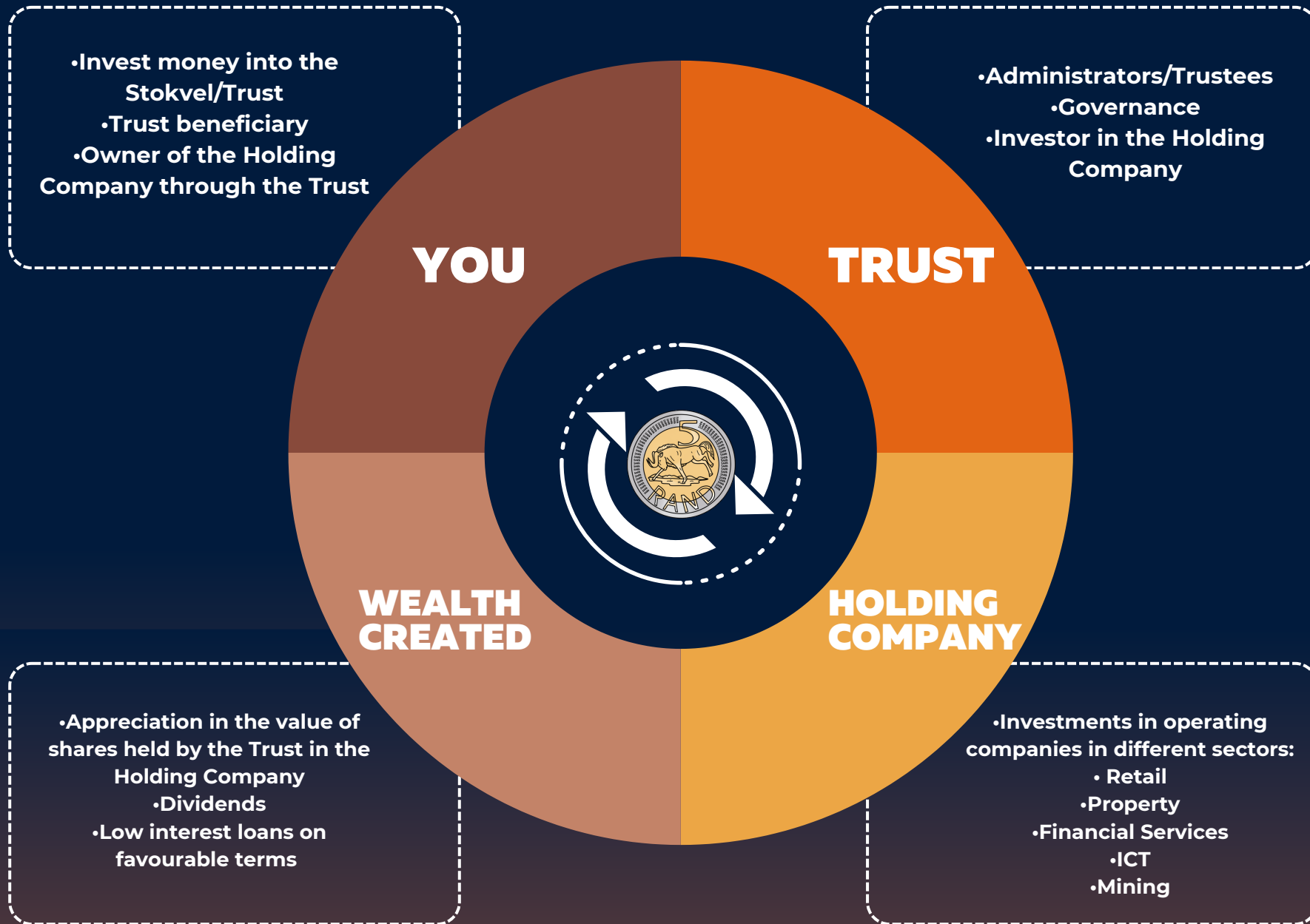
OUR WEALTH CREATION BUSINESS MODEL

FAQ



Who may join?

- Anyone who is an African, currently and previously systematically excluded from the ownership of the economy.
- Natural persons of all ages, unnatural persons and group stokvels.
- Persons who are visionaries that wish to stake a claim in the ownership of the economy.
- Persons who are serious in creating inter-generational wealth for their families.

How much is the monthly contribution?

- With as little as R200 per month, per person you can be a member.
- You can invest as much as one can afford on a monthly basis.

What is the lock-in period?

- The lock-in period as stipulated in the Trust Deed is 10 years.



How is my investment secured?

- Upon joining each investor is allocated a unique investment account number.
- Each account is entitled to a bi-annual statement of account.
- The scheme is governed under a Trust Deed registered in common law with the Masters of High Court of South Africa.
- The Trust is administered by esteemed & respected professionals who subscribe to the King IV standards of Corporate Governance.
- The scheme subscribes to high ethical and moral standards.
- Investment decisions are made by a team of highly skilled professionals, with extensive experience in various sectors of the economy.
- Latest state of the art automated systems are in use to track your investment and its growth.

What are the benefits of investing in the scheme?

- Access to low interest loans at reasonable terms as compared to commercial banks, for all qualifying investors.
