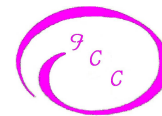

Event will be held Rain or Shine! Overnight security provided. Trash must be removed from event premises, no receptacles provided. No early pack up allowed. Floor length table cloth required. NO Setup until vehicle fully unloaded and moved. Vehicle will be parked by valet parking team.
