

Nitish gov't needed to ensure Bihar uninterrupted development: Modi

ASSERTING THAT REFORMS are impossible in an environment of mismanagement and anarchy, Prime Minister Narendra Modi on Thursday said he needs the Nitish Kumar government in Bihar to ensure that there is no paucity in the state's development and the welfare schemes continue there uninterrupted.



In his four-page letter in Hindi, the prime minister also said that better infrastructure and rule of law are imperative for social and economic prosperity and only NDA can provide that in Bihar.

In an open letter to the people of Bihar ahead of the final phase of voting on Saturday, Modi said people have full faith that only the NDA government can work for the state's development.

"I am convinced about the development of Bihar. I need the Nitish Kumar government to ensure that there is no paucity in Bihar's development and the welfare schemes continue there uninterrupted," he said.

"I have full faith that the power of 'double engine' will take Bihar to new heights of development in this decade," Modi said.

Bihar CM creates flutter with 'last election' remark

BIHAR CHIEF MINISTER Nitish Kumar on Thursday stunned his audience on the last day of electioneering with his remark that the assembly elections under way in the state were his last.

The NDA's chief ministerial candidate was addressing a rally at Dhamdah in Purnea district. Campaigning for the last of the three-phase election ended on Thursday.

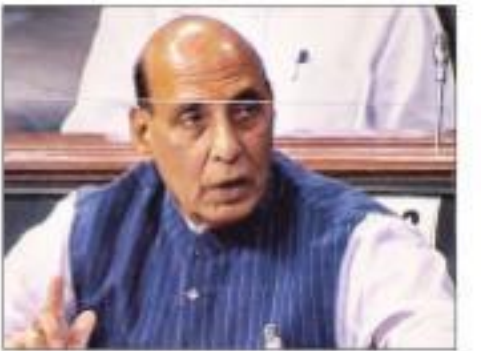
"Today is the last day of campaign. Polling will take place day after tomorrow. This is my last election (ye mera antim chunav hai). All is well that ends well (ant bhala to sab bhala)," said Kumar, his outstretched arms betraying the emotions he concealed behind his smiling face.

The crowds were stunned into silence for a few seconds, after which they erupted in applause for the 69-year-old leader who has ruled the state for nearly 15 years. —PTI

Indian Army to press for expeditious disengagement at 8th round of talks

THE INDIAN ARMY is set to press for comprehensive disengagement of troops by the Chinese PLA from all the friction points in eastern Ladakh at the eighth round of Corps Commander-level talks on Friday, official sources said.

The talks are slated to begin at 9:30 am in Chushul on the Indian side of the Line of Actual Control (LAC) in eastern Ladakh, the sources said on Thursday.

Nearly 50,000 Indian Army troops are currently deployed in a high state of combat readiness in various mountainous locations in eastern Ladakh in sub-zero conditions as multiple rounds of talks between the two sides have not yielded concrete outcome to resolve the six-month-long military standoff.

The Chinese People's Liberation Army (PLA) has also deployed an equal number of troops, according to officials. —PTI

Arnab moves HC, challenges his 'illegal arrest'

REPUBLIC TV EDITOR-IN-CHIEF Arnab Goswami has petitioned the Bombay High Court challenging his "illegal arrest" in a 2018 case of abetment of suicide of an interior designer, and sought quashing of the FIR lodged against him by Alibaug police in Maharashtra.

A division bench of Justices S S Shinde and MS Karnik will hear the plea on Thursday afternoon. Goswami was arrested on Wednesday from his residence at Lower Parel in Mumbai and was taken to the Alibaug police station in neighbouring Raigad district. He was later produced before a magistrate's court in Alibaug which remanded him in judicial custody till November 18. —PTI

China's Xi to attend virtual summit of SCO heads of state

CHINESE PRESIDENT XI Jinping will take part in the virtual summit of the SCO council of heads of state and put forth his proposals to consolidate solidarity, mutual trust, strengthen multilateralism and promote the steady development of the grouping in the post-Covid era.

The Shanghai Cooperation Organisation (SCO) summit over video link will be organised by Russia, which will also host a virtual summit of Brazil, Russia, India, China, South Africa (BRICS) leaders on November 17.

Addressing a special media briefing here on Thursday on the attendance of Xi at the SCO summit, China's Vice Foreign Minister Le Yucheng said that the Chinese President will discuss with other leaders new approaches and measures to tackle risks and challenges, and promote security, stability and development.

Prime Minister Narendra Modi is expected to take part in the virtual summit on November 10, the first multilateral meeting to be attended by Modi and Xi since the border standoff began in eastern Ladakh in May.

Le ruled out bilateral meetings during the summit as it is a virtual summit and hoped for the resumption of face-to-face meetings in the post-Covid phase.
