Treasurer: Treasurer's Report – Summary (Year ending 30 June 2025)

Rebecca Wallis presented the financial report on behalf of Terri Lomman Stone for the year ending 30 June 2025. **Key points included:**

The club remains in a sound financial position, with the bank balance increasing by approximately \$40,000 compared to the previous year. Some costs are still to come relating to the club wind-up.

Sponsorship income grew, which assisted in reducing player fees, while additional fundraising efforts supported community affordability.

Administration costs have increased, and it was agreed that annual fees rise by \$15 per player, plus \$10 fundraising, to cover these costs. Fees for the 2026 season are as follows: Junior \$225 + \$16.50 WAFC Fee; \$131.50 inclusive of all registration fees.

Expenditure was managed carefully despite a slight reduction in overall income. Stock levels were confirmed, and a small outstanding loan remains.

The Treasurer commended the committee for their efforts in managing spending, securing sponsorship, and strengthening the club's financial base. The Treasurer expressed apologies for being unable to attend the AGM and thanked Rebecca Wallis for her assistance with the role. The Treasurer confirmed willingness to continue in the role unless another volunteer wishes to step in.

A designated clash jumper will only be used where required during derby or opposition matches, at the discretion of the Club.

**The proposal aims to:**

Strengthen the connection and pathway between juniors and seniors by aligning colours with the South Mandurah Football and Netball Club.

Provide a unified and recognisable identity across all Junior and Youth teams.

Increase brand visibility and sponsorship opportunities.

Streamline ordering, distribution, and size allocation of jumpers.

Reduce production costs and reliance on alternate sets.

Minimise colour clashes with opposition teams.
