14. REVOCATION

In the event of winding up of the Trust at any point of time, the whole of the corpus fund and other funds and all movable and immovable properties belonging to the Trust or the Institution maintained by the Trust shall only be transferred to any public charitable Trust or institution having similar aims and objects to be selected by at least 4/5 majority of the Trustees.

15. COMPROMISE/ ARBITRATION

The Board of Trustees shall have the power to settle or compromise, out of court, all suits and other proceedings and to settle all differences and refer any suits, action or other proceedings, differences or demands to arbitration and to execute releases and to do all things necessary, in its view, in the best long interest of the trust.

The Trust and the Corpus Funds shall be irrevocable for all times. In witness whereof the parties hereto have hereunto set their respective hand, on this **1st Day of September of 2008.**
