- I am an agent of Landlord Corporation and assist in operating the building on a day-to-day basis.
- 2. I submit this affidavit in support of the motion to restore based upon personal knowledge.
- 3. Pursuant to the Consent Order dated January 8, 2016, Petitioner was to provide access to the landlord on January 25, 2016 and January 26, 2016 to correct certain violations. A copy of the January 8, 2016 Order is attached hereto.
- 4. While the Petitioner did allow access on the first access date of January 25, 2016, not all of the violations were corrected on that date and my workers and I needed the second access date of January 26, 2016 to complete work.
- 5. Unfortunately, the Petitioner denied access to my workers and me on January 26, 2016.
- 6. Respondent needs access to the Petitioner's apartment as soon as possible to complete

- 7. Petitioner's failure to provide access to the Respondent greatly prejudices the Respondent.
- 8. This motion should be granted in its entirety.
