Dear Assistant District Attorneys Kathryn Taylor & Kimberly Grinberg:

I hope that you all remain personally unaffected by Covid-19 and also hope the DA's office is following the US Supreme Court's protocol, which, as I trust you know, had its first day of remote arguments yesterday.

Realizing any change in policy takes time to implement, I am obviously curious about any update on my submission to you over 3 weeks ago and am particularly interested in knowing whether the case is being transferred to the experts in the Special Housing Unit/SHU.

I'm also interested in knowing whether you've attempted to download my evidence via WeTransfer. Normally, I receive notification when a download occurs and I've yet to receive one – so am not sure whether there is some issue with the system.

To simplify the download process given the volume of data involved, I elected to pay for a subscription at \$12/month as it allowed me to send all 3.5G at one time (2G/day is generally the max for free).

I would sincerely appreciate it if you would download the evidence or ask the SHU to download it on or before May 9th so I can cancel the subscription by May 10th. The other option after that date is that I resend the evidence broken up into a few attachments over 2 days when someone there is in a position to receive and download it.

Thank you in advance for your understanding and consideration.

Dear Assistant District Attorney Kathryn A. Taylor:

Thank you, again, for meeting me on March 10, 2020. I understand how busy you are and the demands on your time, and I also appreciate that you have to weigh the likelihood of a conviction at trial when deciding whether to move forward with a complaint/prosecution. I am therefore very grateful that you would make time to review and discuss the factual basis for my request to have Shpend (aka "Joey") Nezaj prosecuted for aggravated assault, an action that is directly related to underlying landlord-tenant issues ongoing for over 5 years. Again, Joey is, or was, the operating agent of my 38-unit rent-restricted building at 83 Park Terrace West in Manhattan, still owned by Joey's father, Hamdi, under the corporate name Kosova Properties ("Hamdi/Kosova"). Given that I had to rush through my evidence in the meeting, I will also be sending via WeTransfer the official recording from Housing Court of what I claimed was felony perjury on Joey's part, so that you can make a final decision on that, too. To reiterate, though, I hope this will all be in collaboration with, or taken over by, the Special Housing Unit.

Attached are two encrypted documents:

- (1) The cover letter, which summarizes not only the immediate material but adds a few other considerations that due to their sensitive nature, I prefer not to reference in an open email and
- (2) the main document, which explains both the history and the physical evidence coming in digital form for the alleged assault and perjury by Joey.

The password for the two documents will arrive via your telephone voice-mail. It is being encrypted in an abundance of caution due to its sensitive nature. For internal use, you can strip the password by going to the top menu in Word (->Tools->Protect Document) and simply deleting it.

Last, given your suggestion that the court documentation I was showing for Joey's perjury wasn't believable and my concern that you may elect to dismiss the massive amount of physical evidence and explanation because of other cases on your agenda, I want to emphasize one point in the attached documents.

It appears that you may not have examined the link in my Newsletter #9, which takes you to the brief history by Fair Housing Justice Center ("FHJC") and the case against the Nezaj clan in Federal Court. In it, you will see that Norman Lear, the well-known and highly-regarded filmmaker/producer, starts personally exposing the Nezajs (and Hamdi in particular, who is shown in the documentary) for racial discrimination in the already released A House Divided. This is one of the reasons that Hamdi paid \$620,000 to the plaintiffs in 2017, and racial discrimination is one of the reasons Hamdi and Joey have engaged in a pattern of harassment and intimidation (including the assault in 2018) against me: I was supporting FHJC because Hamdi and Joey had engaged in illegal actions against me, given that two of my roommates in six years (2009 and 2015) happened to be black, as explained further in the attachments.

As I discuss more in the Cover Letter, because Hamdi owns 19 buildings, it's fair to assume that there are many more victims than me (three others were in my building alone, who are documented in the materials I'm sending to you). I expect Lear's film, which begins to expose the Nezaj clan to the world, is just the beginning of an exposé and that the silence of other victims is coming to an end. If you aren't willing to take my word, I suggest you call Lear, FHJC or its lawyer, Diane Houk of Emery Celli Brinkerhoff and Abady LLP.

Subject: Delay because of COVID-19

Dear ADAs Taylor and Grinberg,

Given the chaos that I read has ensued in NYC, the court system (and the court systems around the country), I gather you won't be unhappy with me delaying the material I promised to send this week.

Also, it seems pointless to send the documents and digital recordings to you via an internet service like WeTransfer (because they're too big for email attachments), if my multiple issues are, as I would hope, to be taken over by the Special Housing Unit (SHU).

I wait, then, to hear from you before proceeding, and have almost finished scanning and explaining everything so that I can provide the SHU with everything remotely to be able to go forward by phone or video-chat.

Presumably, though, ADA Grinberg will provide them with all the material I gave her on the USB drive in November, including:

- Two videos from the day of the assault, 21 Nov 2018;
- · Two videos from 24 Aug 2018 (which led to the 34th writing a Police Report for Harassment by Shpend aka Joey Nezaj, although, as always, the 34th did nothing to him afterwards, not even warn him about repeating);
- Newsletter #9;
- the photos of my lobby, where Joey's assault occurred;
- $\cdot\,\,$ and a photo of the keys I was holding in my hand when his assault started and when I tried to defend myself.

Using the totality of my evidence, I'd want to start from the beginning with the SHU, but not in a rushed fashion, as it has led to misgivings and misunderstanding by you and is not fair to me, especially given that your office has prosecuted me and then dropped the charges twice, in 2016 and 2019.
