## **Additional Clauses**

## **Producer Credit and Compensation Clause**

#### 1. Producer Credit:

The Producer shall be credited as ["D\$TAY1K"] in all formats and media where the Composition is distributed, released, promoted, or otherwise exploited, including but not limited to digital platforms, physical packaging, liner notes, streaming metadata, and any promotional materials. Credit shall be in a size, style, and placement no less favorable than that accorded to any other producer.

## 2. Compensation:

The Producer shall be entitled to receive 15-30% of all gross revenue derived from the sale, streaming, licensing, synchronization, or other exploitation of the Composition and/or Master Recording. This percentage shall be calculated after deduction of any third-party platform fees but before deduction of other expenses.

#### 3. Registration and Accounting:

The Artist (or Label, as applicable) agrees to register the Producer's contribution with all relevant Performing Rights Organizations (PROs), digital distributors, and metadata services upon release of the Composition. Producer shall be listed as a producer and rights holder wherever applicable.

#### 4. Finality of Sales:

All sales and registrations shall be deemed final. The Artist shall not revise, remove, or alter the Producer's credit or percentage of rights/revenue after registration, except with the express written consent of the Producer.

# **Modifications**

This Privacy Policy may be amended from time to time in order to maintain compliance with the law and to reflect any changes to our data collection process. When we amend this Privacy Policy we will update the "Effective Date" at the top of this Privacy Policy.
