

### **Photography Policies for Matchday Services**

**1. Overview** North Bear Media is committed to providing professional photography services in alignment with FA safeguarding guidelines and venue-specific requirements. These policies outline the steps we take to ensure the privacy, security, and consent of all individuals involved in our matchday photography services.

### 2. Permissions and Consent

- **Parental and Coach Consent**: Photographs will only be taken of players whose parents and coaches have provided explicit consent.
- **Opposition Team Permissions**: Prior agreement will be secured from both team managers before any photography begins.
- **Consent Tracking**: A digital system (e.g., Google Form or website form) will be used to collect and document parental permissions efficiently.
- **Participant Notification**: Parents and participants will be informed in advance whenever a professional photographer will be present.

## 3. Privacy Measures

- **No Identification**: Players will not be identified by name in any photographs. Images will only reference the team and kit number.
- **Background Blurring**: Individuals not part of the consenting team will be blurred out in all images to maintain their privacy.
- **Restricted Access**: Photos will be stored securely and only accessible to parents with the appropriate permissions through an access-controlled platform.
- **Handling Non-Consent**: Children who should not be photographed will be clearly identified using visual indicators, such as wristbands or other recognisable markers, provided by the team or club.

# 4. Secure Storage and Deletion Policy

- Secure Storage: All images will be encrypted and stored in secure digital locations.
- Access Control: Images will only be available for purchase through a password-protected platform.
- **Deletion Policy**: Images will be permanently deleted from our systems and the platform 30 days after they are made available for purchase.

### 5. Identification and On-Site Protocol

- **Photographer ID**: The photographer will wear visible identification at all times while on-site.
- **Venue Coordination**: The photographer will liaise with venue staff or managers at each venue, ensuring compliance with their specific requirements before any matchday activities commence.
- **Prohibited Areas**: No photographs will be taken in changing rooms, toilets, or any other restricted areas.

## 6. Safeguarding Compliance

- **FA Guidelines**: All activities will comply with the FA's safeguarding guidelines for photographing and filming children.
- Complaint Handling: Any concerns raised by parents, coaches, or venue staff will be addressed promptly and appropriately, with escalation to the FA or venue management if necessary.
- **DBS Checks**: All staff involved in photography services will hold an up-to-date DBS check to ensure compliance with safeguarding standards. Copies of DBS checks are available on request in writing.
- **Social Media Awareness**: Parents and spectators will be advised of the risks of sharing tagged images on social media and the importance of thoughtful sharing practices.
