- Matching students with companies and internship programs;
- Assistance with visa documentation, accommodation, and logistical support.

We act solely as an **intermediary** between students and host companies. We do not employ the students or guarantee internship placement, visa approval, or employment outcomes.

#### 3. Eligibility

Our services are available **only to individuals aged 18 or above**. By registering with Life in Asia, you confirm that you are of legal age and have the legal capacity to enter into binding agreements.

## 4. Fees and Payment

All service fees are paid by the student.

The applicable fees will be clearly communicated before confirming participation in any program.

Payments must be made through the methods indicated on our Website or via official

## 5. Cancellations and Refund Policy

- Cancellations must be communicated in writing to **getinfo@lifeinasia.nl**.
- Refund eligibility depends on the stage of the process:
  - o **Before profile submission to host companies:** 80% refund of total fee.
  - After profile submission but before placement confirmation: 50% refund.
  - o After internship confirmation or visa processing begins: no refund.
- Administrative fees and third-party costs (e.g., visa fees, accommodation deposits, full service in Japan) are **non-refundable**.
  - Life in Asia reserves the right to modify this policy in exceptional circumstances or force majeure cases.

## 6. Responsibilities of the Student

Students are responsible for:

- Providing accurate personal and academic information.
- Ensuring compliance with visa and travel regulations.
- Maintaining professional conduct with host companies and local partners. Failure to comply may result in termination of the placement without refund.

#### 7. Responsibilities of Life in Asia

Life in Asia agrees to:

- Provide accurate information about available internships and host companies.
- Support students with pre-departure preparation and practical guidance.
- Ensure all data processing complies with the EU General Data Protection Regulation (GDPR).

However, Life in Asia cannot be held liable for:

- Visa rejections, travel restrictions, or border closures;
- Actions or conduct of third-party companies, landlords, or institutions;
- Losses, injuries, or damages incurred during the internship or stay abroad.

## 8. Limitation of Liability

To the maximum extent permitted by law, Life in Asia shall not be liable for indirect, incidental, or consequential damages, including loss of income, opportunities, or data, arising from the use of our services.

Our total liability under these Terms shall never exceed the amount paid by the student for the specific service.
