PAYMENTS: You have several options for payments for group bus trips. You can make payments via CashApp, Venmo or via the registration from. You can pay by PayPal or Credit card via the form. REFUND POLICY: All payments are non-refundable and non-transferable. We have agreements with the vendors, such as the motorcoach company, hotels, and other vendors that will not allow us to obtain any refunds.

CANCELLATION: If the bus trip is cancelled for any reason or we have to change the date, you are eligible for a 100% refund. If you are not able to attend due to a date change, you must notify us within 48 hours of the change of date, that you will not be able to attend. Please contact us as by the information provided above.

DISABILITIES: It is your responsibility to opt in to our trip, if you believe it is suitable to your physical capabilities. We may not be able to offer guests any assistance if you require this due to a physical disability, sight or hearing impairment, or require any special service assistance. You are welcome to attend, but may need to bring someone that can assist you with any special needs or services. This person will also be required to purchase a ticket for the trip. Our motorcoach service cannot accept service animals. Please let us know in advance if you require any special equipment or special storage needs, so that we can confirm if they can be accommodated prior to your payment.
