VISHESH GRANT TO SPECIAL CHILDREN WITH 70 % OR ABOVE DISABILITY

(KINDLY READ THE INSTRUCTIONS CAREFULLY BEFORE FILLING UP THE FORM)

SCHEME

The scheme provides financial assistance to special children having disability of 70% or more. The benefits at the rate of ₹ 3000 pm (₹ 36000 pa) are provided to the parents till the child attains 30 years of age irrespective of whether the child is going to school or not.

ELIGIBILITY

- 1. The grant will be paid upto the age of 30 years.
- Disability percentage should be 70 and above.
- 3. Disablility certificate has been issued from either service hospital or any other Govt/Non-Govt hospital notified by Govt to issue such disability certificates.
- 4. Air warriors, MBOs, widows and NOK having minimum pensionable service can claim Financial Assistance under Vishesh grant.

DOCUMENTS TO BE ATTACHED

- 1. The application form duly completed in all respects is to be sent to the Secretary, IAF Benevolent Association, AFGIS Bhavan, Subroto Park, New Delhi 110010 along with the following documents:-
 - (a) Latest copy of disability certificate indicating disability percentage of the child, issued by service hospital/civil hospital notified by Central/ State Govt and duly attested by SMO/CMO/MO/ECHS Hospital
 - (b) Extract of POR duly authenticated by Unit Adjutant indicating Date of Birth of Child.

An attested copy of Date of Birth certificate.

- (c) Copy of pay pension order as a proof of drawing pension.
- (d) Two latest passport size photograph of the child.
- 2. Continuation of VISHESH grant will be made at the end of each financial year on receipt of the following documents by Mar every year:-
 - (a) Receipt/acknowledgement of last payment received.

And

- (b) **Case 1**: Where disability is permanent/non progressive/not likely to improve and reassessment is not recommended at all, no further disability certificate is required **or**
- (c) Case 2: Where disability is permanent/temporary and reassessment is recommended after a specific tenure, disability certificate is required after the expiry of validity of the disability certificate

or

(d) **Case 3**: Where disability is temporary or it is not clearly stated about re-assessment in the disability certificate, fresh/renewed disability certificate is required with attestation of SMO/ECHS/MO/CMO every year

GENERAL INSTRUCTIONS

- 1. The VISHESH scheme is applicable to the PHMC Children, having 70% or more disability. The scheme is applicable to both serving/ retired air warriors and widows. The benefits under the scheme are paid upto the age of 30 years of the child.
- 2. In case of serving air warrior application will be forwarded to IAFBA under a covering letter duly signed by Unit Adjutant. For retired/ deceased category the signing authority would be Zila Sainik Board/ Air Force Association.
- 3. The list of Service/ Civil Hospitals notified by the Govt. for issuing of disability certificate is available on the IAFBA website.

- 4. Disability Certificate issued by any other hospital (not in the list) should be notified by respective State Government/ Union Territory, for issuing such disability certificates.
- 5. Part III of the application form should be countersigned by Stn Cdr of nearest AF unit with Office seal or by Secretary Zila Sainik Board in case of retired/deceased.
- 6. Incomplete applications will be returned back.
- 7. The Executive Committee reserves the right for amending any clause or discontinuing the scheme and also for individual sanction and its continuation to any individual.
- 8. Any point for clarification may be referred to the Secretary of the IAF Benevolent Association.
- 9. Individual will opt for NEFT facility for online direct transfer of amount in their bank account by giving their bank a/c details through cancelled cheque/bank passbook attested by Bank Manager.
