WAIVER AND RELEASE AGREEMENT

ATTENTION: Please read carefully before signing. This is a legally binding document that constitutes a COMPREHENSIVE release of liability and waiver of SIGNIFICANT legal rights.

In consideration for my being permitted to participate in the activities (**hereinafter, the "Activities"**) of **Double Alpha Ranch LLC, its successors, assigned, and affiliates**, I agree to the following Waiver and Release:

ACKNOWLEDGMENT AND ASSUMPTION OF RISK

I acknowledge that paper and/or steel target shooting, **and all related activities** have **numerous and inherent** risks, hazards, and dangers for anyone that cannot be eliminated, particularly in a wilderness environment and when firearms are involved.

I UNDERSTAND THAT THESE RISKS, HAZARDS, AND DANGERS INCLUDE WITHOUT LIMITATION:

1. The risk of handling firearms and being near others that have firearms in their possession, **including the risks associated with the negligent, willful, or intentional acts of other participants or third parties.**
2. The risk of ear damage from noise.
3. The risk of injury from ammunition; **including, but not limited to, misfires, hang fires, negligent discharge, ricochets, and back spatter.**
4. Walking in rugged country, including encounters with wildlife, animals, and insects.
5. Inclement weather conditions, **including lightning.**
6. **The risk of injury or death resulting from my own conduct, decisions, or lack of skill.**
7. **The risk of equipment malfunction, failure of range or shooting area components, or premises defects, whether known or unknown.**

I **have fully informed myself of** the risks, hazards, and dangers of the use of firearms and have had the opportunity to discuss them with management of Double Alpha Ranch, LLC.

I understand that these activities require good physical conditions and a degree of skill and knowledge. I have the good physical conditioning and the degree of skill and knowledge necessary for me to engage in these activities safely. **I confirm that I am solely responsible for my own safety and judgment during the Activities.**

I understand that I have required safety responsibilities. I understand that eye and ear protection must be worn when engaged in or watching other participants shooting. **I further agree to comply with all rules, instructions, and safety procedures established by Double Alpha Ranch, LLC, and all Federal and Georgia State laws.**

My participation in this activity is purely voluntary. No one is forcing me to participate, and I elect to participate despite the risks.

I am **VOLUNTARILY** USING THE SERVICES OF **DOUBLE ALPHA RANCH, LLC** WITH FULL KNOWLEDGE OF THE INHERENT RISKS, HAZARDS, AND DANGERS INVOLVED AND HEREBY **EXPRESSLY** ASSUME AND ACCEPT ANY AND ALL RISKS OF INJURY, PARALYSIS, **LOSS, DAMAGE, OR DEATH.**

WAIVER, RELEASE, AND INDEMNIFICATION

Lastly, I, for myself, my heirs, **assigned**, successors, executors, and subrogates, hereby **KNOWINGLY, INTENTIONALLY, AND IRREVOCABLY** WAIVE AND RELEASE, INDEMNIFY AND HOLD HARMLESS, Double Alpha Ranch, LLC **and all its respective** directors, officers, agents, employees, and volunteers (**collectively, the "Releasees"**) from and against any and all claims, actions, causes of action, liabilities, suits, expenses (including reasonable attorney's fees) which are related to, arise from or are in any way connected with my participation in this activity including, but not limited to, **ANY AND ALL NEGLIGENCE** of any kind or nature, whether foreseen or unforeseen, **including the SOLE, JOINT, or CONCURRENT NEGLIGENCE of the Releasees**, arising directly or indirectly out of any damage, loss, injury, paralysis, or death to me or my property as a result of my engaging in these activities or the use of these services, animals or equipment, whether such damage, loss, injury, paralysis, or death results from negligence of firearm use or from some other cause, **including, without limitation, the acts or omissions of any other person or participant.**

I, for myself, my heirs, my successors, executors, and subrogates, further agree not to sue Double Alpha Ranch, LLC **or any of the Releasees** as a result of any injury, paralysis, or
