Applications are invited online only through One Time Registration Scheme from qualified candidates for selection to the undermentioned post in Kerala Government Service. Candidates who have already registered can apply through their profile.

1. **Department** : **Kerala Higher Secondary Education**
2. **Name of Post** : **Higher Secondary School Teacher in Geology**  
**EXPLANATION** : Higher Secondary School Teacher means Full Time Post of Higher Secondary School Teacher
3. **Scale of pay** : **₹ 55,200 – 1,15,300/-**
4. **Number of vacancies** : **03 (Three)**

The above vacancies are now in existence The Ranked list of selected candidates published by the Commission in response to this notification shall remain in force for a minimum period of one year, provided that the said list will continue to be in force till the publication of a new list after the expiry of the minimum period of one year or till the expiry of three years whichever is earlier. 5. **Method of appointment** : Direct Recruitment
6. **Age limit** :
  1. 20-40. [Only candidates born between **02.01.1985**. and **01.01.2005**. (both dates are included) are eligible to apply for this post.
  2. Relaxation in upper age limit upto 43 (Forty Three ) years as on the 1<sup>st</sup> day of January 2025 shall be allowed to the qualified Ministerial Staff under Higher Secondary Education Department for direct recruitment to the category of Higher Secondary School Teacher . **7. Qualifications :-**

- (i) Master's Degree in the concerned subject with not less than 50% marks from any of the Universities in Kerala or a qualification recognized as equivalent thereto in the respective subject by a University in Kerala.
- (ii) (1) B.Ed in the concerned subject acquired after a regular course of study from any of the Universities in Kerala or a qualification recognized as equivalent thereto by a University in Kerala.  
(2) In the absence of persons with B.Ed. Degree in the concerned subject, B.Ed Degree acquired in the concerned faculty as specified in the Acts and Statutes of any of the Universities in Kerala.

- (3) In the absence of persons with B.Ed. Degree as specified in items (i) and (ii) above, persons with B.Ed. Degree in any subject acquired after a regular course of study from any of the Universities in Kerala or a qualification recognized as equivalent thereto by any of the Universities in Kerala.
- (iii) Must have passed the State Eligibility Test (SET) for the post of Higher Secondary School Teacher conducted by Government of Kerala or by the agency authorized by the State Government.

Note:-

1. Rule 10 a (ii) of Part II of KS & SSR is applicable.
2. In addition to the qualifications prescribed in the notification, the qualifications recognized by executive orders, or standing orders of Government as equivalent to a qualification specified for the post, in the Special Rules or qualifications found acceptable by the Commission since acceptance of equivalent qualifications is provided for in the Rules and such of those qualifications which pre-suppose the acquisition of the lower qualification prescribed for the post, shall also be sufficient for the post. The copy of the Government orders declaring equivalent/higher qualifications shall be produced as and when required by the Commission.
3. The Degrees / Diplomas awarded by UGC approved universities or Institutions established through an act passed by Parliament / State Legislative assembly in accordance with the conditions laid down in G.O(M.S) No. 526/PD dated 17.07.1965 are acceptable for appointment in Government Services

4. In the absence of B.Ed Degree holders, candidates having Master's Degree with not less than 50% marks and who have passed the State Eligibility Test (SET) will be considered. Preference will be given to those who have acquired Ph.D / M.Phil degree or qualified at Junior Research Fellowship / National Eligibility Test. The teachers appointed under this provision will have to acquire B.Ed Degree at their own expense within five years from the date of entry in service.
5. Persons who have acquired M.Ed in the concerned subject recognized by any University in Kerala are exempted from B.Ed qualification.
6. In the case of difference in Caste/Community claimed in the application and that entered in SSLC book, the candidate shall produce a Gazette notification in this regard, along with non Creamy layer Certificate /Community Certificate at the time of certificate verification.
7. Candidates who have acquired Non-qualifying Degrees viz. Ph.D/M.Phil/Post Doctoral Fellowship will be awarded weightage marks provided that such Non-Qualifying Degrees shall be in the subjects pertaining to the basic qualification stipulated for the post. Weightage marks for Non-qualifying Degrees for ranking will be awarded as detailed below.

Non-Qualifying M.Phil- 2 marks

Non-Qualifying Ph.D- 4 marks

Both M.Phil and Ph.D (Non-Qualifying)- 5 marks

Post Doctoral Fellowship- 2 marks

Non-qualifying degree means the additional qualifications which are earned apart from the qualifications insisted on as essential qualifications for the post. If Ph.D/M.Phil/Post Doctoral

Fellowship is reckoned as necessary qualification for the post, weightage marks will not be awarded for it. Weightage marks will be awarded only to those non-qualifying degrees which are claimed in the application and which are acquired on or before the last date for receipt of applications.

#### **Exemptions**

1. Those who have passed the State Level Eligibility Test (SLET) for the post of College Lecturers conducted by Government of Kerala are exempted from passing the State Eligibility Test for Higher Secondary School Teachers.
2. Those who have passed the National Eligibility Test/Junior Research Fellowship shall be exempted from passing the State Eligibility Test.
3. Persons with Ph.D/M.Phil/M.Ed. degree shall be exempted from passing the State Eligibility Test provided the M.Phil in the concerned subject should be one awarded by any of the Universities in Kerala or recognized as equivalent thereto by any of the Universities in Kerala.
4. Teachers who have completed 10 (ten) years of approved teaching service at the High School level in the General Education subordinate service shall be exempted from passing the State Eligibility Test. [GO(P) No.37/2005/Gl.Edn dated -4/2/2005]

5. Relaxation of 5% marks in the post Graduation will be given to SC/ST and Differently Abled candidates as per G.O.(Ms) No.288/15/Gl.Edn.Dated 13.11.15

#### **8. Mode of submitting Application:-**

- (a) Candidates must register as per 'ONE TIME REGISTRATION' with the Official Website of Kerala Public Service Commission [www.keralapsc.gov.in](http://www.keralapsc.gov.in) before applying for the post. Candidates who have registered can apply by logging in to their profile using their User-ID and password. Candidates must click on the '**Apply Now**' button of the respective posts in the Notification Link to apply for the post. Those candidates who create new profile should upload their photograph taken within six months. Name of the candidate and the date of photograph taken should be printed legibly at the bottom portion. The photograph once uploaded meeting all requirements shall be valid for 10 years from the date of uploading. There is no change in other instructions regarding the uploading of photographs. No application fee is required. Candidates are responsible for the correctness of the personal information and secrecy of password. Before the final submission of the application on the profile candidates must ensure correctness of the information in their profile. They must quote the User-ID for further communication with the Commission. Application submitted is provisional and cannot be deleted or altered after submission. **Candidates are advised to keep a printout or soft copy of the online application for future reference. Candidates can take the print out of the application by clicking on the link 'My applications' in their profile. All correspondence with the Commission, regarding the application should be accompanied with the print out of the application.** The application will be summarily rejected if non-compliance with the notification is found in due course of processing. Original Documents to prove qualification, experience, age, Community etc. have to be produced as and when called for.
- (b) If Written/OMR/Online Test is conducted as part of this selection, candidates shall submit a confirmation for writing the examination through their One Time Registration profile. Such candidates alone can generate and download the Admission Tickets in the last 15 days till the date of Test. The applications of candidates who do not submit confirmation within the stipulated period, will be rejected absolutely. The periods regarding the submission of confirmation and the availability of Admission Tickets will be published in the Examination

Calendar itself. Information in this regard will be given to the candidates in their respective profiles and in the mobile phone number registered in it.

- (c) Appropriate disciplinary action as per Rule 22 of the Kerala Public Service Commission Rules of procedure shall be initiated against those candidates who submit applications with bogus claims of qualifications regarding education ,experience etc and are liable to be disqualified for being considered for a particular post or debarment from applying to the Commission either permanently or for any period or the invalidation of their answer scripts or products in a written/practical test or the initiation of criminal or other proceedings against them or their removal or dismissal from office or the ordering of any other disciplinary action against them if they have already been appointed or any one or more of the above
- (d) Candidates are required to acquaint themselves with the instructions given in the notification as Part II, General Conditions before submitting application for the post. Applications which are not submitted in accordance with the terms and conditions laid down in the General Conditions are liable to be rejected.
- (e) Candidates who have AADHAAR card should add AADHAAR Card as I.D Proof in their profile.
