Subject: Request to investigate and complaint against soldiers successfully recruited to army based on fraudulent documents through Army rally conducted at Army requirement office located at Kolhapur, Pune, Colaba/Mumbai and Aurangabad.

Respected sir,

Army recruitment process had taken place at Army recruitment office, Aurangabad for 1050 soldiers between 21/07/2015 to 07/08/2015. After the recruitment process, in the investigation of documents of successfully recruited students, Chief officer of recruitment - Hon'ble Colonel Mohanpal Rampal Singh has found that 43 applicants have produced fraudulent documents. He has filed F.I.R 189/2016 in Cantonment 5 Aurangabad, Police station against these students under articles 420, 468, 471.

Out of 43 applicants, 42 were from Maharashtra and students of "Police and Army pre-recruitment training center", public trust no. F-7799, Name - Adarsh Career academy Bahaddurwadi, Tal. Walwa, Dist. Sangli. For this recruitment more than 450 students appeared from the trust. Ten buses from MAHARASHTRA STATE ROAD TRANSPORT CORPORATION, Islampur Depot were used for the travel of these students.

Some of the suspected criminals, in the F.I.R filed by Hon'ble colonel from Aurangabad, have "again" joined the Army based on "fake" bonds even though result of the case is still pending. Army recruitment office has not evaluated the documents and has not taken 'appropriate' actions on the students even though 3 years and 1 month has already passed.

Sir, according to information provided by MSRTC Islampur depot under the Right to Information act, in the year 2015 and 2016, 33 buses went for rally to Mumbai Army recruitment office. Based on the capacity of the bus, approximately more than 1500 students have appeared to rally through the trust. Out of these students, more than 150 students have successfully recruited to Army and their documents are not verified by respective recruitment authorities.

'THOUSANDS' OF STUDENTS EVEN BEFORE JULY 2015 AND AFTER DECEMBER 2016 BASED ON FRAUDULENT DOCUMENTS HAVE APPEARED TO RALLY AND 'HUNDERADES' ARE SUCCESSFULLY RECRUITED IN ARMY THROUGH ADARSH CAREER ACADEMY TRUST. THEREFORE, REQUEST TO RESPECTIVE AUTHORITIES TO TAKE


