महाराष्ट्र राज्य में हमारे देश की सेना में भर्ती करने के लिए कुलाबा, पुणे, कोल्हापूर, औरंगाबाद और नागपूर के आर्मी रिक्रूटमेंट ऑफीसेस भर्ती की प्रक्रीया करते हैं। भर्ती के समय उम्मीदवारों को सिमीत जिलों के अधिवास होने का नियम है।

21/07/2015 से 06/08/2015 तक औरंगाबाद के नजदिकी सिमीत जिलों में अधिवास होने वाले उम्मीदवारों के लिए आर्मी भर्ती रैली हो रही थी। इस रैली में कोल्हापूर आर्मी रिक्रूटमेंट के सिमित जिलें कोल्हापूर, सांगली और सातारा जिलों के चारसौ पचास से जादा उम्मीदवारोंने भर्ती रैली में अधिवास (डोमेसाईल) राष्ट्रीयत्व (नॅशनॅलीटी) रहिवासी (रेसीडेन्सीअल) इन दस्तावेजों की फोटो कॉपी जिनपर राजपत्रीत अधिकारियों के झुठे सिक्के और दस्तखत करके भर्ती में शामिल हो गए हैं। जिनमें से बयालीस उम्मीदवारोंका अंतिम चयन हो गया था।

भर्ती के मुख्याधिकारी कर्नल मोहनपाल सिंह रामपाल सिंह को दस्तावेजोंपर शक होने के बाद उन दस्तावेजों का सत्यापन किया।

सत्यापन में बयालीस उम्मीदवार कोल्हापूर, सांगली और सातारा जिलों के होने के पक्के सबुत पाये गए। 'इन बयालीस अंतीम चयन हो चुके जवानों के साथ मध्यप्रदेश के एक उम्मीदवार का अंतीम चयन हो गया। ऐसे कुल तैतालीस जवान फर्जी दस्तावेज देकर सेना में भर्ती हो चुके हैं' यह माननीय कर्नलजी को समझ में आ गया।

तारीख 26/05/2016 को औरंगाबाद में महाराष्ट्र पुलिस थाना छावणी (कॅन्टोनमेंट 5) इसमें इन तैतालीस जवानों का कर्नल मोहनपाल सिंह रामपाल सिंह ने F.I.R. 189 से धारा 420, 461 और 471 से अपराध दर्ज किया।

F-7799 के नाम से पंजीकरण ट्रस्ट आदर्श करीअर अकॅडमी (पुलीस और सेना भर्ती का पुर्व प्रशिक्षण देनेवाले) इसके है । इन बयालीस अपराधीयों में से कुछ सन 2017 से आर्मी में झुठे (अफीडेव्हीट) शपथपत्र देकर नौकरी कर रहे हैं । जिसके शपथपत्रों का पडताल 18 महिनो में आजतक नहीं हुआ है । आदर्श करीअर अकॅडमी ट्रस्ट ने अपने आर्थिक फायदो के लिए कुलाबा, पुणे, औरंगाबाद और कोल्हापूर में बहुत संख्यासे जवानों को झुठे दस्तावेज देकर अंतीम चयन किया है ।

सुचना का अधिकार नियम 2005 (R.T.I.) से महाराष्ट्र स्टेट रोड ट्रान्सपोर्ट कॉर्पोरेशन (M.S.R.T.C.) तारीख 05/10/2017 को राज्य परिवहन इस्लामपूर से जानकारी मीली है । जानकारी आदर्श करीअर अकॅडमी ट्रस्ट बहादुरवाडी को सेना भर्ती के लिए ज्यादा बुकिंग से भर्ती को जानेवाले बसों कि है । जो जुलै 2015 से दिसंबर 2016 तकही सिमीत है ।

यह जानकारी हमे बता देती है की, कुलाबा, पुणे और औरंगाबाद में सेना भर्ती के समय पैतालीस यात्री क्षमता वाली तैतालीस बस भर्ती को जा चुके थे । बसों को आदर्श करीअर अकॅडमी ट्रस्ट के उपाध्यक्ष शिवाजी शंकर खोत ने बुक किया था । लगभग 1935 तक फर्जी दस्तावेज होनेवाले उम्मीदवार ट्रस्ट के बुक बसों से भर्ती को जा चुके थे ।

औरंगाबाद (F.I.R.-189) के अपराधी 18 महिनो से झुठे शपथपत्र (अफीडेव्हीट) देकर सेना में काम कर रहे है ।

आदर्श करीअर अकॅडमी के खिलाफ स्थानिय पुलीस थाना शिकायत नहीं ले रहे हैं ।

“शायद सेना भर्ती करने वाले अधिकारी और कर्मचारी भ्रष्टाचार के पैसे लेकर प्रमाणपत्रों की जाँच पडताल नहीं करते है” ।

महोदय जी,

फर्जी दस्तावेज देकर सेना में अंतीम चयन होना और जिसकी जाँच पडताल न होना यह बात हमारे देश की सुरक्षा के लिए खतरा है । फर्जी दस्तावेज देकर आर्मी में भर्ती होनेवाले उम्मीदवारों की जाँच पडताल करके उनपर कानुनी कारवाई होनी चाहिए यह आपसे यिनती है ।

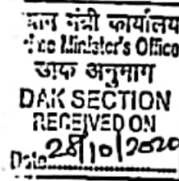

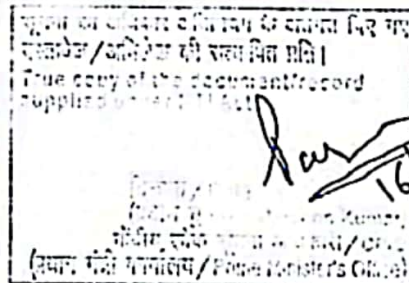



Subject: Request you to advise Hon'ble Director of Central Bureau of Investigation Mr. Rishi Kumar Shukla to take actions against opponents mentioned in my complaint application submitted on date 16/05/2019 with registration no. 1775/19 received on that side office on 06/06/2019.

Hon'ble sir,

I have complained to that office to make justice for serious economic loss that was done to me, Cheating and submission of fraudulent documents in Indian Army recruitments, corruption that is being done in the complete process. I tried to complain at relevant authorized Police stations of Maharashtra state police, but I was unsuccessful. When I tried to file a F.I.R. on 30/03/2019, Mr. Mahale of Atpadi Police station told me that "Area of the financial transaction is not under the authority of the Atpadi Police station". Therefore, I complained at Ashtha Police station on 31/03/2019 (Correct Police station under which the place at which financial transaction happened is managed) but, Mr Khambe at the Ashtha Police station did not accept my complaint due to unacceptable/negligible reasons. Therefore, I have complained to C.B.I. headquarter office New Delhi to get justice to my financial trickery and corruption done in the Army Recruitment process with strong and valid proofs.

I have received 'Copy of information' by post which is an ORDER of hon'ble director general of the Anti-Corruption Bureau of state of Maharashtra to hon'ble superintendent of Police, Sangli on 20/08/2020 Informing him to take actions against opponents mentioned in my complaint form which is given by me to C.B.I. Hon'ble superintendent of Police transferred that file to divisional police station of my village - "Vita Police station, Vita". Investigation officer of Vita Police station - Mr. Jadhav has asked me detailed information about my complaint on the phone on 14/09/2020.

After realizing that there were no actions taken on my complaint, I wrote the request form on 28/09/2020 to Deputy Superintendent of Police, Anti- Corruption Bureau, Sangli district to take actions against the opponents and tell me the purview. (Copy of Information was also sent to Superintendent, Sangli and Deputy superintendent, Vita).

I and my opponents were called for 'hearing' of the case on 09/11/2020 at divisional Vita police station. I was out of town, so my brother Mr. Santosh Kashinath Khilari attended the hearing on my

behalf. I ensured to Investigation officer Mr. Neeraj Barpatre on phone that I will be present for the next hearing whenever scheduled.

Now, deputy superintendent police has concluded and gave result that "my case is of type CIVIL and not A CRIMINAL", suggesting me to go to civil court for justice. I have not been informed about any kind of information or opinions of my opponents or investigation details or actions that are taken in investigation.

Result given by divisional police station has shocked me and has incurred serious toll mentally because of below reasons-

1. My financial trickery
2. My serious accident as an aftermath of the economic harassment
3. Two incidents of cheating of Indian Army by opponent no.1 Ganesh Ramdas Khilari by supplying fraudulent documents and bonds.
4. Participation of "Thousands" of students in the Indian Army Recruitment rally based on fraudulent documents and bonds, and "Hundreds" of them have already successfully joined the Army illegally by giving money to A Public trust (Public Trust No. F-7799, Sangli) and favouring more occurrences of corruption.

These crimes have really happened and evident, validity of which is possible to be checked with all the proofs I have had attached. But results of Vita Police station stated that my application was not of type "CRIMINAL CASE".

Hon'ble sir,

Please advise to validate my complaint with the supporting documents and evident proofs that I have joined. Also, request you to tell relevant authorities to check the information I have attached to that application and register the First Information Report in C.B.I. office. Please bring me justice and STOP THE CORRUPTION IN THE ARMY RECRUITMENT WITHOUT ANY FURTHER DELAYS.

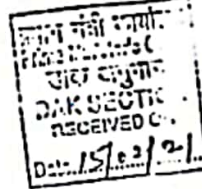


