The subject of the application: India Country is unsafe to visit by the VVIPs of other countries.

The reference to send this application: The Prime Minister of India Mr. Narendra Modi visited Mumbai city for the planned program on 19<sup>th</sup> January 2023. A National Security Guard commando was found with a fake document. The central government gave The Order to The Indian Army and The Intelligence Bureau of India to find the reason for a deliberate mistake. Because of the cause of the security of an Indian VVIP. There are hundreds of soldiers in the Indian army enrolled by submitting fake documents. Ruling parties and opposition parties leaders of the government and related administration have known it. But they

are neglecting to verify the documents and to take the action against them. It's Dangerous to the security of other VVIPs like an Indian VVIP.

Reasons for the allegation of the recruitment process of the Indian army: My country's recruitment process is implemented through The Zone Recruiting Offices (for limited states near the Z. R. O.) and after by the Army recruiting offices (for limited districts near the A.R.O.) gradually. Any youth must be a permanent resident of the limited district intended for military recruitment.

**Proof of the Army recruitment scam in the Indian army:** A recruitment rally was held in the year 2015 for thousand and fifty vacancies for the Aurangabad A.R.O. office of Maharashtra state. But after the recruitment process, the Director of Recruitment Colonel Mr. Mohanpal Singh Rampal Singh got doubted on the domicile certificates of some of them suspicious. Therefore, he has corresponded with the concerned Tehsil office about the verification of the docomments. In that, they got information that the documents of forty-three soldiers out of the total were fake. So he registered a "cheating with the government" case in the related police office against them on 26<sup>th</sup> May 2016.

Status of that registered case: A total of thirty-seven accused were arrested on their own at the police station. The government and the administration do not want to arrest the rest of the accused in the criminal case despite having information about their residences along with the case registered with evidence. Nearly eight years are gone, but the case is in Pending status in the Honorable court.

The key to finding corruption in army recruitment: There is a trust which is enrolled in A Charity Commissioners office. (Adarsh career academy, Bahaddur wadi, Tehsil: walawa District: Sangli) Working for The Police and Army Pre-Recruitment training center. Ten buses of Maharashtra state road transport corporation were gone to the Aurangabad army recruitment rally. "All of the students was went to that the rally" is a statement of the chairman of that trust in an investigation report of a related police station. Thirty-nine accused from a total of forty-three of that criminal case are students of that trust.

My cousin brother is an accused in that case who was a student of that Academy. The incumbents of that trust took the five lack rupees from each successfully recruited student in that rally. I was given the all required amount to that trust for my cousin as a friend loan at the request of the mother and father of my cousin ( They are the uncle and aunty of mine.)

The academy enrolled my cousin in the army through the other A.R.O. Where his domicile is true but the character certificate is fake. Because he is not acquitted by the honorable court in the above case. (The Direct General of India's Army recruitment about the complaint application I was given to the Chief of Army Staff replied to me that it's illegal and a crime. But my cousin is on the duty in the Indian army though the government and related administration have known that he is a Criminal.)



The best way to find corruption in the army recruitment systems: The financial trickery done with me by my relatives who are written above. The complaint application I have given to the Central Bureau of Investigation against my relatives and the incumbents of the related trust is sufficient to find a way of corruption in the recruitment system of the whole country. But the related C.B.I. officer enclosed my file and send it to the Defense Ministry of India.

The opinion of the honorable Prime minister about the Scam in the Army recruitment: I was given the complaint application with strong proof but the prime minister closed my file with the answer that the Indian army procedure is fair and transparent. (I have done the allegation that more than five hundred soldiers are recruited with fake domicile certificates who were a student of the Adarsh career Academy but they are not verified by related officers like Mr. Mohan pal singh because of corruption. I know What will my punishment be if I am Wrong.)

( The related documents I have attached with this application are written/ typed in other than the English language, But It's possible to translate them into the required languages.)

I think it would be dangerous for VVIPs from other countries to visit my country before the check of security conditions. I hope that you will share this information with other countries.


