Petition to the Supreme Court of The United States of America

We the People of the United States hold that when we are denied the ability to choose our own representatives in a free, fair, and transparent election, that our most basic of rights and the number one principle that our constitutional republic is founded on, that of the consent of the governed, has been violated, and therefore the current government of these United States no longer possesses just powers derived from We the People of the United States.

Such has been our patient suffering while we have attempted to redress these issues with the government, including to this very court, but instead we have been met at every turn with a long train of abuses and usurpations pursuing invariably the same Object, which evinces a design to reduce us under absolute despotism. To prove this, let facts be submitted to this court and to a candid world.

In violation of the tenets of open elections which are free, fair, and transparent:

Our votes have been diluted with the participation of non-citizens in the election process.

The burden of proof has been speciously placed on the citizen who has been given an inordinately short period of time in which to show that enough fraud has occurred to have changed the outcome of the election, instead of properly being placed on the government to positively show that elections were run fairly in accordance with law.

Our rights to view our public records have been continually violated through nefarious means such as extraordinary legal procedures, excessive fees, and other obstacles. Public records are not public records if We the People are denied easy and open access to them. To add insult to injury, the government has spent profligately from the public treasury using our own money to deny us our rights to view our own records, while forcing the citizen to spend exorbitantly to defend those rights through the judiciary with a time consuming process. The hubris of this is extraordinary.

Our right to view and verify the actual voting process has been violated with the use of unsecure electronic machines which hide the process behind a technological curtain, while We the People are incorrectly informed that we cannot pierce that veil, because the rights of the corporations to their proprietary process outweigh our rights to view our own public records.

American citizen's rights come before corporate rights; this obfuscation is not only patently absurd, but the exact opposite of transparent.

The electronic records of these machines are inadequate, inaccessible to citizens, unsafe in determining votes as they have already been shown in a court of law to possess the vulnerability to be hacked, and they therefore violate the principle of free and fair elections. Nothing is as secure as paper ballots marked by the individual.

Our right to ensure electoral outcomes has been hindered by the moving of paper ballots or electronic records from local precincts before they are hand counted and therefore are much more vulnerable to fraud.

The duty of the government to maintain accurate voting rolls has been grossly violated, with some jurisdictions actually having more voters than eligible population, allowing for all kinds of fraud and shenanigans to occur within the balloting system.

The allowance of extended voting and mail in ballots in place of one day in-person voting in conjunction with lax or non-existent means of identification and signature verification of persons has led to egregious violations of our right to free and fair elections and has opened the electoral system to massive amounts of fraud that is akin to a modern-day digital ballot box stuffing operation.

This petition is a appeal to the highest court in the land directly from We the People for you to defend our rights and uphold your oaths to defend the Constitution of the United States of America that each of you swore; failure to do so will leave us no choice but to find you in violation of that sacred oath.

We are not asking, we are demanding free, fair, and transparent elections now; that you find the current electoral system in gross violation of the principle of consent of the governed, by denying the citizenry the ability to verify the vote; and that you rule that a system that gives us the ability to view and count the votes ourselves must be implemented.
