



Corporación Intergestión (CorpoIntergestión), identified with the NIT 900.357.159-7, located at Cl. 1a 51a-45 in the city of Bogotá D.C., with the phone number in Bogotá: (601) 483 9984 and the website [www.corpointergestion.org](http://www.corpointergestion.org), as the Data Controller, in compliance with the provisions of Law 1581 of 2012 and Decree 1074 of 2015, informs you that it will directly or through third parties process personal information, including collecting, storing, using, circulating, registering, administering, reporting, processing, employing, evaluating, analyzing, transferring, transmitting, confirming, updating, and deleting data in accordance with the conditions established by the data subject, under standards of confidentiality, security, transparency, accuracy, timeliness, and restricted access and circulation.

The personal information will be processed for the following purposes:

- a) Sending correspondence and notifications.
- b) Contacting the Data Subject through any means, particularly but not limited to email and/or cell phone.
- c) Sending information about activities, events, products, and/or services of the Organization through the channels or means established for this purpose.
- d) Conducting market research, statistics, and surveys within the framework of the social statutes and policies of CorpoIntergestión.
- e) Allowing access to CorpoIntergestión facilities.
- f) Capturing images through video surveillance systems to ensure the safety of individuals and property within CorpoIntergestión facilities.
- g) Using the Data Subject's image to create notes or videos and publish them in various media to highlight CorpoIntergestión's activities and services.
- h) Contacting stakeholders for brand positioning and reputation management.
- i) Managing procedures (requests, complaints, and claims).
- j) Transferring and/or transmitting Personal Data within or outside the country to companies economically linked to CorpoIntergestión (subsidiaries and affiliates), third parties, contractors, or partners, so they may process the Personal Data in accordance with the provisions of the Personal Data Processing Policy.
- k) Other general and specific purposes outlined in our Personal Data Processing Policy.

As the Data Subject, you have the following rights: (i) to access, free of charge, the personal data provided to CorpoIntergestión that has been processed; (ii) to know, update, and correct your personal information; (iii) to request proof of the authorization granted to CorpoIntergestión; (iv) to be informed by the Data Controller or Processor about the use of your personal data; (v) to file complaints with the Superintendency of Industry and Commerce for violations of current regulations; (vi) to revoke the authorization granted and request the deletion of data when constitutional and legal principles, rights, and guarantees are not upheld; (vii) to refrain from answering questions about sensitive data or data concerning children and adolescents.
