

Participation Agreement & Liability Waiver

The purpose of the courses and events is to provide participants with a practical and objective introduction to shooting sports. The safe, responsible, and legally compliant handling of firearms is always the highest priority.

This document serves as information and obliges all participants to comply with the following points.

1. Legal Requirements

I confirm that I meet the legal requirements in accordance with the Swiss Federal Act on Weapons, Weapon Accessories and Ammunition (SR 514.54) as well as the Weapons Ordinance.

I confirm that:

- I am at least 18 years old (for minors, written consent from a legal guardian is required)
- I am at least 18 years old (for minors, written consent from a legal guardian is required)
- There is no official prohibition against me regarding weapons or their handling
- There are no criminal convictions or ongoing proceedings relevant under weapons law that could exclude participation. This includes violations of weapons and narcotics laws, driving while unfit to drive, as well as repeated commission of crimes or offenses
- There is no legal status that prohibits me from handling weapons under Swiss law
- I am not a citizen of any of the countries listed in Article 12 of the Weapons Ordinance (Serbia, Bosnia and Herzegovina, Kosovo, North Macedonia, Turkey, Sri Lanka, Algeria, Albania)

2. Personal Requirements

I confirm that there are no indications that I could endanger myself or others through the handling of weapons. This includes in particular:

- **Mental, physical, and emotional fitness**
I am in a stable mental, physical, and emotional condition. There are no health or psychological limitations that could impair my reaction or judgment during this event.
- **Influence of substances**
I have not consumed alcohol, drugs, or any other substances that alter consciousness or impair perception before or during the event.



- **Anti-constitutional or extremist organizations**

I am not a member of any organization or group whose objectives or activities are incompatible with the rule of law and freedom-oriented values of Switzerland.

I do not engage in any political or religious activities that glorify violence or endanger the state.

3. Safety Rules
