2. Quality Control & Product Standards

Before export, products undergo a multi-layered quality control process implemented by PT. Sinergi Nusantara Berdikari to ensure consistent product quality and standards that meet international quality standards and customer expectations.

Quality Control & Product Standards Practices:

- Incoming Quality Check
 - Physical selection: size, color, moisture level, cleanliness.
 - Manual and mechanical sorting per customer standards.
- Product Standardization
 - Based on SNI (Indonesian National Standard), Codex Alimentarius, and international buyer standards (ISO, HACCP, USDA, EU).
 - Parameters: physical characteristics (shape, size, color), moisture level, aroma, essential oil content (spices), caffeine content (coffee), etc.
- Multi-Level QC System
 - QC at production site (partner & internal team).
 - QC at company warehouse.
 - QC at pre-shipment (by third-party labs).
- Documentation & Reporting
 - Each batch has a Quality Report & Export Database.
 - Digital recording system for transparency and audits.

3. Third-Party Laboratory Testing

To ensure that products meet international standards, each product to be exported is tested based on physical content (moisture content, density, color, size), chemical content (pesticide residues, heavy metals), humidity, microbiology, and other residues as requested by the customer.

Third-party laboratory testing practices conducted::

- Accredited Laboratory Collaboration
 - Partnering with ISO/IEC 17025 certified labs.
 - Inspection & verification partners: SGS, TUV, Intertek, Cotecna, Sucofindo.
- Test Parameters:
 - Chemical: (pesticide residues, heavy metals.)
 - Physical: (moisture content, density, size, color.)
 - Biological: (microbes, fungi, contamination.)
 - Commodity-specific (e.g., essential oil content for cloves, caffeine for coffee).
- Documents Produced:
 - Certificate of Analysis (COA).
 - Detailed Quality Test Reports (as requested by customers).



4. Export Documentation & Certification

Every export must be accompanied by official documents to comply with Indonesian and destination country regulations. PT. Sinergi Nusantara Berdikari ensures that the process and preparation of Export Documents & Certificates run smoothly. We provide responsive, attentive, and supportive services to our customers.

5. Distribution Handling & Container Loading

- Certificate of Analysis (COA) from independent laboratories to ensure product quality and safety (moisture content, composition, pesticidefree, etc.) according to customer requirements.
- Halal Certification for food products in compliance with MUI/LPPOM standards and customer needs, particularly in Muslim-majority markets.
- Customs & Trade Documents: Invoice, Packing List, Export Declaration (PEB), and customs clearance documents.
- Fumigation & Insurance Documentation: Fumigation certificates for packaging and international cargo insurance policies.
