Hello,

I sent a request to the City of Springfield for a copy of the contract with Future IQ for the Project 2051 initiative. They replied that the City gave \$50,000 to the project, but the other monies came from other organizations, such as Ohio Department of Development, Clark County, the Walter Quinlan Foundation, the Wilson Sheehan Foundation, the Turner Foundation, the Springfield Partnership.

Of course, they sent me to you for information. Since most of these organizations are largely funded by federal, state, **County**, and **City** government tax dollars, I am sure you would agree that the citizens of Springfield have a right to know how much we are paying for (whether nonprofit, Foundation, or City/County - it's all our tax dollars) the contract for the Project 2051 Springfield initiative.

I am requesting a copy of the contract (or whatever form Future IQ submitted) and the dollar amounts to include:

- Total cost (including travel, expenses, billable hours or lump sum payments, etc.)
- Sources of all monies coming from any organization funding this project and how much from each (I imagine you get paid from one organization and they reimburse each other. What organization do you send your invoices to? Is it Clark County?)
- Was there an RFP? How was Future IQ selected? Who were the decision makers? Springfield, Ohio, to Australia? I'm just trying to make that make sense.

I'm sure you can understand the citizens' many frustrations here, as the city and county government and nonprofit leaders (they are essentially the same thing here) are THE problem. They have created and continue to create the division in this city to keep the focus off the corruption and the decade-long mission to replace people who have lived here their entire lives. I'm slso sure they've tried to convince you that it's all a race or intolerance issue. Mayor Rob Rue keeps telling us and the entire world that we, the citizens, are dangerous. If the city and county wanted the endless stream of money to continue, they had to bond together in the lies to our faces and about us in front of us, the city, the county, the state, and eventually the country and then the world.

There was evidence presented to the City Manager for YEARS about the animals being eaten alone, but the City Attorney spun the word "pet" into "domesticated animals" so the citizens could be called liars and get the media involved to use the word "hoac" in every article or post. It never was a hoax and remains truth. Now, though, it's advanced to all sorts of illegal activities that the City/County do not collect data on when it involves Haitians.

So, the division is intentional. We are not the problem nor the cause. The corrupt inner circle has worked toward one end - a decade-long plan to use the citizens' money to "restructure" the city. Then, lucky for them, the Biden administration years provided the extra means of the entire country's tax dollars to accomplish their goal to destroy and remove the citizens from the town. If they haven't left, they are scared and silent. They don't even vote. Why would they?

It feels like there is a nonprofit, NGO, or Foundation for every citizen here, all complicit in the spending of the endless flow of money the town and county have seen in the last several years. The money from taxpayers all over the country had to go somehwere, and it certatinly couldn't be spent on the citizens. That wasn't and still isn't the plan. No problem has ever been addressed, much less solved. You can watch YouTube videos of biweekly Commission meetings for the last several years - they consist of citizens PLEADING for help that has YET to be even thought about, much less addressed. The majority of funds goes to the leaders of nonprofits, of course - this is universal. Their latching onto other people's tax dollars and profiting like never before is also universal. But the vast number of organizations here is unique.

Not to mention the businesses and housing industry who received millions of dollars hiring Haitians for jobs, to the exclusion of the citizens. We weren't even in the running. The homeless population increased due to so

many citizen taxpayers being evicted from their homes to make room for the Haitians who they can successfully rent to for thousands more dollars. Then, the state sent us money to help with resources, to which the Governor responded with \$10 million for translation services and a new urgent Care for the Haitians. Anything to punish us in supports of their plan to replace the people who have lived here all their lives.

All that to say, greed and corruption is rampant and all around. This city just reeks of it and will destroy it long before 2031, much less 2051.

We just spent \$100,000 on another outsourced Community Needs Survey in June 2025. We were told results would be published but they never were. This is very small potatoes when it comes to the "mismanagement of funds" here. Of course, the city has no data on that \$100K or the survey results, because "the city did not handle that; it was done by an outside company". They do use all the tricks in the corruption bag. And they'll use them for your project, as well.

Just as an FYI - In your presentation on September 23rd, you mentioned a goal of 1,000 surveys?? The citizen population of Springfield alone is \sim 58,000. If you are including non-citizens (which I would hope you aren't), it's \sim 88,000. If you are depending on the Commission to hand out surveys to their associates and friends, you are not getting anywhere near the actual community. If you're looking to Chris Wallace for input or help, think again - he is running for a Commission seat. Nobody in the town has ever even heard of the man. He's run a time or two before, I believe, and lost miserably. He's latched onto you for the publicity, I imagine.

You also mentioned the groups and people you are interviewing around Clark County, none of whom are the voices of the citizens AT ALL. In fact, they are the very ones who will intentionally and completely misrepresent us. Some of those you mentioned are 100% dependent on and recipients of the city/county and nonprofit money flow. The taxpayers foot all their bills, but we receive no money or benefit in return. We are ignored and called names (again, to the entire country). The money is for the insiders and the non-citizens, as intended. The Mayor, City Commission, and mostly the City Manager, who controls the money, are the most egregious.

Most people wouldn't dream of completing yet another survey, because we all know this is just money to burn and utterly meaningless. People don't even vote here anymore. What's the point if Bryan Heck and the likes of the Springfield Foundation and City and County Commission are in charge for the duration?

Thank you for your time and attention. I look forward to your reply with the answers to my questions. I hope you will help us. No one here has or ever will again. Not now, not in 2031, not in 2051.
