

WHEREAS, the City Commission wishes to provide a financial contribution to the Springfield Foundation toward the Future IQ Community Action Plan Project, which is a collaboration of entities across the community to collect and analyze data as well as develop a comprehensive strategy and action plan for Springfield/Clark County; and

WHEREAS, the City believes that its support of the Project, by providing partial funding, will accomplish an important and proper public purpose; NOW, THEREFORE:


BE IT ORDAINED by the City Commission of The City of Springfield, Ohio:

Section 1. That the foregoing recitals are made a part of this Ordinance and this City Commission hereby adopts the findings set forth in the recitals to this Ordinance.


Section 2. That a contribution to the Springfield Foundation in the amount of \$50,000.00, payable in two installments of \$25,000.00 in 2025 and \$25,000.00 in 2026, toward the Future IQ Community Action Plan Project, which is an expenditure to accomplish a proper public purpose, is hereby authorized.

Section 3. That this Ordinance shall take effect and be in force from and after fourteen (14) days from the date of its passage.
