EV World Expo Goa 2026 – Exhibitor Information

Event Details

EV World Expo Goa 2026 will be held at **Goa Panjim Expo Centre** on **28 & 29 January 2026**. The exhibition focuses on Electric Vehicles, EV components, charging infrastructure, batteries, renewable energy, and sustainable mobility solutions.

Exhibitor Manual

All exhibitors are required to strictly follow the guidelines mentioned in the **Exhibitor Manual**, available on our official website. Non-compliance may lead to restrictions, penalties, or cancellation of participation without refund.

Stall Allocation

Stalls are allotted on a **first-come, first-served basis** upon receipt of the completed Exhibitor Form and payment confirmation. An exhibitor may book **multiple stalls**, subject to availability.

Payment & Refund Policy

- Full payment is required to confirm stall booking.
- **No refunds** will be provided once payment is made.
- **GST @ 18%** is applicable in addition to the stall charges.

Stall Inclusions (per 3m x 3m Built-up Stall)

- **3 Exhibitor Passes** (food & beverages not included)
- **1 Counter Table & 3 Chairs**
- **1 Power Socket (5A, 230V)**
- **3 Spotlights**
- **1 Waste Basket**
- **25 One-Time Visitor Passes** (common for all stall sizes)

Stall Handover Timings

- **Raw Space:** 27 January 2026 – 10:00 AM
- **Built-up (Shell Scheme):** 27 January 2026 – 4:00 PM

Setup & Dismantling

All stall setup must be completed by **5:00 PM on 27 January 2026**. Exhibitors must clear all packing material and non-display items by this time. Only display-related items are permitted inside the stall during exhibition hours.

Security & Liability

General security will be provided at the venue. However, the organizers shall **not be responsible** for any loss, theft, or damage to exhibitor property, products, or display materials.

Conduct & Compliance

Exhibitors must ensure that their activities do not disturb neighboring stalls. Any **live demonstrations, product launches, vehicle displays, charging demos, or performances** require **prior written approval** from the organizers.

Space Usage

All promotional activities, displays, and demonstrations must be strictly confined within the **allotted stall area**. No encroachment into aisles or neighboring spaces is permitted.

Layout Modifications

The organizers reserve the right to make changes to the **floor plan, stall layout, or stall location** if required for safety, operational, or organizational reasons.

Damages

Exhibitors shall be fully responsible for any damage caused to stalls, venue property, electrical fittings, or equipment. Damage assessment and repair charges decided by the organizers will be **final and binding**.

Jurisdiction

All disputes, if any, shall be subject to the **jurisdiction of courts in Goa, India** only.

- **29 January 2026:** 10:00 AM – 6:00 PM

Additional Services

- Additional furniture, power supply, branding elements, and AV equipment can be arranged through the **official stall contractor** at extra cost.
- Exhibitors opting for **Raw Space** must submit their stall layout for approval on or before **15 January 2026**.
- Continuous power supply or special electrical requirements may attract **additional charges**.
