

## FREMONT PEAK REPEATER ASSOCIATION NET SCRIPT

GOOD EVENING. THIS IS <YOUR NAME> <YOUR CALLSIGN> IN <YOUR LOCATION>, YOUR NET CONTROL STATION FOR THIS SESSION OF THE FREMONT PEAK REPEATER ASSOCIATION NET.

THIS NET IS HELD EVERY MONDAY EVENING AT TWENTY-HUNDRED HOURS FOR THE PURPOSE OF CONTACTING ALL STATIONS INTERESTED IN THE ASSOCIATION AND ITS ACTIVITIES.

ALL PARTICIPATING STATIONS ARE REQUESTED TO STATE THEIR CALLSIGN, NAME CITY AND THE NATURE OF THEIR TRAFFIC AS THEY CHECK INTO THE NET, AND TO STAND BY WHEN EMERGENCY OR PRIORITY TRAFFIC IS BEING HANDLED.

SWAP ITEMS SHOULD BE OF AN AMATEUR RADIO INTEREST ONLY. WHEN LISTING A SWAP OR WANT, PLEASE STATE THE MAKE, MODEL AND YOUR TELEPHONE NUMBER.

ALPHABETICAL CALL GROUPS WILL BE USED TO PROVIDE MAXIMUM UTILIZATION OF NET TIME. CONTACTING STATIONS ARE REQUESTED TO ARRANGE ALTERNATE FREQUENCIES AS APPROPRIATE FOR THEIR QSO'S OR TO UTILIZE THE REPEATER FOLLOWING THE NET

BEFORE BEGINNING FORMAL CHECKINS FOR THIS EVENING, ARE THERE ANY STATIONS THAT HAVE EMERGENCY OR PRIORITY TRAFFIC, ALL OTHER STATIONS PLEASE STAND BY.

**A --- D, E --- J, K --- O, P --- T, U --- Z** ...PLEASE CHECK IN NOW.
