Flaming Cheese Burn 2025 Official Waiver and Release of Liability

Please read this waiver carefully and completely. You will need to electronically accept this waiver during the ticket registration process to qualify for ticket purchase.

As an attendee of Flaming Cheese Burn ("the Event") at Sweetwood Tenemos ("the Location"), I voluntarily assume any and all risks of serious injury, death, and/or property damage caused by or resulting from my attending the Event. I hereby release and indemnify the Event, Twisted Kindling LLC, and the Location from responsibility for any direct, indirect, or consequential damages or loss, including serious injury, death, or damage to property, that may occur as a result of my attendance at the Event.

I understand that the Event is an interactive community of artists, performers, attendees, and participants creating and displaying both small and large scale artworks. The Event is held in a remote, wooded, and hilly environment. I expressly acknowledge and agree that activities of the Event and the environment of the Location may be very dangerous, and may involve risks of serious injury, death, and property damage. The risks of serious injury, death, and property damage may include, but are not limited to: the nature of large scale art at the Event, actions of other persons attending the Event, the area and local environment where the Event is located, and rapidly changing weather conditions.

On behalf of myself, my heirs, and my assigns I hereby release, hold harmless, and indemnify the Event planners, organizers, property owners, volunteers, artists, attendees, participants, performers, Twisted Kindling LLC, and hold each of them harmless from any liability if I am injured, die, or sustain damage to property while participating in the Event.

I understand that minor children must be under the supervision of a parent, a legal guardian, or a designated and responsible adult at all times. I acknowledge that the risks of injury, death, and property loss also exist for minor children at the Event. If I bring any minor child to the Event, I hereby release, hold harmless, and indemnify the Event planners, organizers, property owners, volunteers, artists, attendees, performers, Twisted Kindling LLC, and hold each of them harmless from any liability if said minor child is injured, dies, or sustains damage to property while participating in the Event. Additionally, the Event may have subject matter that some parents/legal guardians may consider inappropriate for their minor children. I agree that if I deem any aspect of the Event inappropriate for my minor child, my sole remedy is to remove my minor child from exposure to that aspect of the Event, which may include or require their exit from the Event.

I have read, understood, and will abide by the official Survival Guide for the Event (available here: https://fcburn.org/survival-guide-waiver)

I am fully prepared for primitive camping for the duration of the Event including bringing sufficient water, food, clothing, and shelter appropriate for the environment and for the entire duration of my attendance at the Event.

I understand that possession, sales, loan or transfer, or any other use of any firearms at the Event and the Location is a violation of policies of the Event and of the Location and will result in immediate ejection.

I understand that possession, sale and/or consumption of illegal drugs is a violation of federal law. The Event is held on private land, and all persons are subject to federal, state, and local laws.

Tickets are non-refundable even if the Event is terminated early or canceled due to harsh weather, acts of nature, force majeure, governmental regulation or action, or other conditions beyond the control of the Event, Twisted Kindling LLC, or the Location. This agreement is a revocable license that may be revoked by the Event or Twisted Kindling LLC for any reason.

I agree that this release, waiver, and indemnification agreement is intended to be as broad and inclusive as is permitted by the laws of the State of Wisconsin. I further agree that if any provision of this agreement is rendered void or unenforceable by reason of any statute, rule, regulation, or judicial order, the invalidity or unenforceability of that provision does not affect other provisions of this agreement that can be given effect without the invalid provision, and that all other provisions of this agreement shall continue to have full legal force and effect.
