He aggressively declared that he "OWNS THAT PICTURE!" "THAT IMAGE IS MINE!" "ETERNAL ACCESS! IF YOU WANT ANYTHING LESS THAN THAT, YOU WILL FILE WITH A FUCKING COURT, AND YOU WILL GET A JUDGE TO GIVE ME A COURT ORDER!" Over the next few days Mannee created the website alexanikolas.net containing conduct constituting defamatory and harassing conduct and the INTENTIONAL INFLICTION OF EMOTIONAL DISTRESS directed towards Michael Gray (exhibits 21, 22, 23).

Manne has been TARGETING MY HUSBAND in order to ISOLATE ME and leave me in a vulnerable position for further UNWARRENTED SURVEILLANCE and INTERACTIONS. He is aware that my husband is my biggest protection.

My last correspondence with Mannee was showing was on November 16th, 2022. On the phone call I communicated that I no longer wanted him to volunteer for my organization 'Eat Predators'. After knowing him for only 7 weeks, mainly Online, Mannee was showing signs of OBSESSIVE AND CONTROLLING behavior. For example, he had my 2 year old daughter's photo pinned to his profile on social media and would send over dozens of messages daily, and CRAZED about my celebrity status. On November 20th, 2022 I was informed that Mannee had violated the privacy of the Eat Predators group chat channel and therefore I decided to remove him for everyone's safety. I blocked him on social media. On November 22, 2022 Mannee made his first physically violent threat towards me when he posted a video implying HE WOULD LEAVE ME "COLD AND DEAD" because my decision took "one more thing that he loved out of his hands" (exhibit 4). On November 23, 2022 Mannee admits to taking screen shots of the group chat (exhibit 5) and THREATENED TO LEAK PRIVATE INFORMATION (exhibit 7). On November 28, 2022 Mannee posted a written statement in reference to me on his social media profile stating his DESIRE TO "KILL [HIS] IDOLS" (exhibit 8).

Mannee reposts the IMAGE OF MY TWO YEAR OLD DAUGHTER (exhibit 51) consistently without authority on his social media accounts and continually creates new posts of the image even after it has been removed from the sites themselves OVER 11 TIMES for VIOLATING the terms and conditions (exhibits 52, 54, 56, 66, 67, 71, 72, 77, 78, 83, 84). He aggressively declared that he "OWNS THAT PICTURE" (exhibit 60) and that "CONSENT IS IRREVOCABLE" and will post it "over and over again" (exhibit 53), which makes me fear for her safety. Mannee has burst of ANGER and is completely DELUSIONAL.

Between November 23 2022 and January 19, 2022 Mannee continued to act to discredit and shame me and those around me by spreading false, delusional, and misleading information in an attempt to baselessly call into question my character, reputation, and mental health. Mannee has GENERATED OVER 300 POSTS about me and has logged around 15 HOURS OF TIME ON VIDEO AND AUDIO RECORDINGS.

Mannee's OBSESSION ESCALATED to PHYSICALLY STALKING at my first public appearance announcing my PREGNANCY while demonstrating at Tri Star Management on January 19, 2023. In his UNWARRENTED VIDEO SURVEILLANCE, Mannee made comments such as "THEY THINK THEY'RE ALL SAFE OVER THERE." (exhibit 13) "I'M GOING THIS WAY. SCARE THEM. MAKE THEM THINK I LEFT." (exhibit 14) After the stalking Mannee conveyed on video that he is "going to stay [in Los Angeles] for a long time, and I'm going to continue to be DISRUPTIVE IN THE LIVES of Eat Predators and ALEXA NIKOLAS and her shitty little husband." (exhibit 15). It should be noted that Mannee moved from Marin County, which was 7 HOURS AWAY from my residence to Sylmar, which is 27 MINUTES AWAY from my residence. He now lives in Burbank, which is 11 MINUTES FROM MY RESIDENCE. All in the span of 8 WEEKS. His harassment has given me anxiety and insomnia.

On January 20, 2023 Mannee posts a photo of a man POINTING A GUN at the screen with the words "NAME EVERYONE WHO LEFT YOU" beneath the photo in the caption lists MY NAME explaining he must "play the role of the villain" (exhibit 17). Over the next few days I highly suspect Mannee created the website alexanikolas.net, opened a twitter account @alexanikolas21, and an instagram account @survivorsofalexanikolas (exhibit 18, 19, 21) averaging 3 posts a day all propagating defamatory information causing severe emotional distress to me and my family. On January 24, 2023 I filed a POLICE REPORT for the FIRST STALKING EVENT that took place (exhibit 24). My report is currently being investigated by Officer Garcia, report #23012400004584, for stalking and harassment.

February 23, 2023 Mannee enforced another UNWANTED INTERACTION when he PHYSCICALLY STALKED me for the 2ND TIME at Red Light Management. Mannee premeditated the stalking with co-conspirator Maurice in order to EMBOLDEN HIS UNWANTED SURVEILLANCE. Upon Mannee's arrival I felt an immediate FEAR FOR MY SAFETY. Mannee refused to leave after the POLICE WERE CALLED (exhibit 46) report #23-001008. Both Maurice and Mannee lied to the Officers Baddour and Jaen stating they were unaware of my public appearance and that Mannee was there to support Maurice in his "musical performance" (exhibit 38, 39, 40, 42). However, On March 2, 2023 in a live video, Maurice admits that he "came out to the protest to support [Mannee]" (exhibit 58). On the same live video Mannee later reveals he "made up the limitations" of their positioning at Red Light "so that [Mannee and Maurice] could" engage in a course of conduct which was designed to VEX, HARASS, AND INTIMIDATE ME WITH NO LEGITAMATE PURPOSE (exhibit 59). His SEVERE DELUSIONS embolden his actions to stalk.

February 25, 2023 I found out that my ABUSER, Michael Milosh, was following my stalker on social media (exhibit 36). The abuse I endured by him was the reason I started Eat Predators. I filed a lawsuit against him in August 25, 2021. He is extremely DANGEROUS and the realization of their interactions reinforced a CREDIBLE THREAT to my life and that of my family. On February 20, 2023 it was reported that Michael Milosh lost a lawsuit in regards to me (exhibit 33) allowing me to refile, therefore would have motive to cause IRREPARABLE HARM or violence towards myself and my family. On February 25, 2023 Mannee confirmed that Michael Milosh "reached out to him to connect" and "so [they] met" (exhibit 49).

At this time I learned how to report Mannee's unsolicited photograph of my TWO YEAR OLD DAUGHTER posted onto his social media accounts. When it was taken down he reposted it and responded "Oh, is this post bothering someone" and "IT'S UP. IT'S PINNED. RIGHT WHERE I PUT IT." (exhibits 53, 55). He is continuing to TARGET MY DAUGHTER and I have a DEEP-SEATED FEAR for her life.

On March 2, 2023 Mannee and Maurice announced they would CONTINUE STALKING ME and harassing me at my next public appearance at TMZ on March 23, 2023 (exhibit 57). On March 8 2023, Maurice and Mannee attempted to EXTORT \$1,000 FROM ME THREATENING he would file a police report and file a civil complaint based on false information UNLESS I PAID HIM (exhibit 73). On March 9, 2023 I went to the POLICE STATION and dropped off the extortion email and Officer Garcia has sent it over to the DA FOR REVIEW. On March 9, 2023 Maurice and Mannee sent an updated extortion email entitled Cease and Desist falsely claiming that "the police officer said there was no police report ever filed" (exhibits 74). Mannee and Maurice went on to post the defamatory and harassing conduct on their social media accounts.



Dear Alexa Nikolas, Michael Gray, and any other legal representatives of Eat Predators,

On February 23rd, Alexa Nikolas violated PENAL CODE 148.5 by making a false report of a crime against me.

The statue reads verbatim:

"(a) Every person who reports to any peace officer listed in Section 830.1 or 830.2, or subdivision (a) of Section 830.33, the Attorney General, or a deputy attorney general, or a district attorney, or a deputy district attorney that a felony or misdemeanor has been committed, knowing the report to be false, is guilty of a misdemeanor."

Alexa Nikolas called the police on me for playing the violin and singing on the same public sidewalk she was protesting on, which is my constitutionally protected right provided by the First Amendment. She told the police that I was an ally of her alleged stalker, and that I was harassing, threatening, and intimidating her by simply being there and performing my music. These false statements were witnessed by her Eat Predators organisation members, including her husband, as well as recorded on police body cameras and documented in the false police report she filed against me.

The stalking law, penal code 646.9, also states verbatim:

"To prove that the defendant is guilty of this crime, the People must prove that:

- 1. The defendant willfully and maliciously harassed or willfully, maliciously, and repeatedly followed another person; AND
- 2. The defendant made a credible threat with the intent to place the other person in reasonable fear for (his/her) safety [or for the safety of (his/her) immediate family].

[A person is not guilty of stalking if (his/her) conduct is constitutionally protected activity. <Describe type of activity; see Bench Notes below> is constitutionally protected activity.]"

Stalking is a serious crime, and exercising my First Amendment right does not count as stalking. The police officers she called to the scene ultimately upheld my First Amendment right to perform and left without charging, arresting, or telling me to leave. Alexa Nikolas knew I was not an accomplice of stalking her, even before she called the police. I informed her and her organisation members multiple times during my performance that I was exercising my First Amendment right and allowed to be there. She is very familiar with the nature of First Amendment protections and regularly exercises her own rights by protesting in public spaces. The Bill of Rights is universal, and does not exclusively apply to her.

I am now seeking a settlement agreement comprised of the following:

- 1. Alexa Nikolas removes and retracts all false statements made about me, including any and all false accusations of being an ally to her alleged stalker.
- 2. Alexa Nikolas makes a public apology for falsely accusing me and calling me a "flying monkey."
- 3. Alexa Nikolas pays me \$1000 in monetary retribution, which is considerably less than the overall costs she would pay in the event of litigation.

These terms are reasonable and negotiable. Once agreed upon, this settlement would halt any legal proceedings initiated by me. Tomorrow I will be reporting these false accusations to the Burbank Police Department, and I will also be filing the defamation lawsuit with the Burbank Courthouse within that jurisdiction.

California law allows 30 days from the date of this settlement demand transmission to accept the offer. After that time, I will not settle for less than these negotiable terms, and I will follow through with all relevant and applicable legal proceedings.

All information in this letter is factual and true. This correspondence is an attempt to settle a legal dispute and falls within the bounds of California law. Any response to this letter should be replied directly using this email thread.

Today I spoke with Officer Garcia from the LAPD and Detective Bingham from the Culver City Police Department. They have both fully updated me on the developments of this case.







- You continued to harass and stalk her at a protest in Los Angeles on February 23, 2023;



- On January 20, 2023, you posted a photo of a man with a gun pointing directly at the viewer and directly referenced Ms. Nikolas and others suggesting they are the targets. You continued this type of threat until March 10, 2023;
- You recently created both a website, Instagram account, and a Twitter account directed at Ms. Nikolas both of which combined already contain over 50 defamatory statements about Ms. Nikolas and thus associated with her.

Your past and current conduct constitute defamatory and harassing conduct and the intentional infliction of emotional distress. As such, we hereby demand that you immediately cease and desist from making any further threats and form making any further false and defamatory statements regarding Ms. Nikolas, her family, or anyone associated with her in any way. Ms. Nikolas will not hesitate to enforce her rights in civil and criminal court and seek injunctive relief, monetary damages, attorney's fees, and any other relief as may be justified under the law.

Ms. Nikolas' legal team will continue to monitor and investigate your behavior going forward, including if any evidence surfaces that suggests that you may be coordinating your actions with Mr. Michael Milosh.


