To the extent that I have appeared at public protests, and otherwise discussed and criticized Petitioner, the conduct is justified as protected speech about her activities with "Eat Predators" and aligned and/or counter-protests and rallies associated with human rights initiatives. I am engaging in Constitutionally protected expression on the subject of "Eat Predators" and its advocacy, "outreach programs", and impact. Discussions of Petitioner character and conduct towards me and others, and assembly at or near public protests, are fully in order with that legitimate purpose.

The most recent alleged "harassment" of 3/19/23 was a publication that included my intent to counter-protest Petitioner protest by peacefully playing music and speaking. It did not constitute stalking or civil harassment. The legitimate speech cited by Petitioner was a brief fragment in the video. A majority of the "hour long video" was not about Petitioner in any way.

My presence at other protests and assemblies, likewise, was done for the legitimate purposes of observation and free expression. It also did not constitute stalking or harassment.

My use of photos of Petitioner's daughter is for the legitimate purpose of showing the close relationship that Petitioner accelerated with me, and for demonstrating her carelessness in caring for and protecting her daughter. These matters pertain to the arguments I make about Eat Predators and Petitioner.

The court does not have jurisdiction to grant any permanent order in this case for the following reasons, as set forth more fully herein.

GROUNDS 1: THE CLAIMS ARE NOT SUPPORTED BY A PREPONDERANCE OF EVIDENCE

Petitioner's evidence isn't directly or clearly attributed to anybody. All transcribed exhibits in Petitioner's "evidence" are void of identification and authentication, including medium of conveyance, timestamping, person speaking, or any context. It is unclear who said what, when and where it was said, who took what footage, what medium anything was said in, or what medium it was conveyed. Petitioner has included no timestamps in evidence.

Petitioner has no perceptible order to evidence, even when on the same page. Exhibits 21, 22, 23, and 86 of Petitioner's evidence are non-existent.

Petitioner incorrectly uses the title "attachment 7a(3) - describe harassment" but doesn't check box on 7a(3), the title she should have used is "attachment 7b - previous harassment".

There are more pages than Petitioner lists in number 17.

A settlement letter is not "extortion" by any stretch of any reasonable person's imagination. It is basic due process in most cases to extend opportunity to settle prior to filing lawsuits. Even after filing the lawsuit, resolution is encouraged by this court via "LASC: Online Dispute Resolution".

The examples Petitioner used for the March 19 2023 incident are from separate dates. The police did not come on March 19 or January 20.

GROUNDS 2: THE ALLEGATIONS ARE LEGALLY BASELESS

Petitioner uses coded language when describing me to incite fear of laws, such as "emotional distress". Petitioner uses "emotional distress" to fill in the form justifying her claim of being injured. Hurt feelings are not what a restraining order is for. Restraining orders are for violence, threats, and legitimate harassment, as technically defined in California Code of Civil Procedure section 425.16 as "a knowing and willful course of conduct directed at a specific person that seriously alarms, annoys, or harasses the person, and that serves no legitimate purpose."

Petitioner states that I created and am running profiles and websites I have no association with. The only profile exposing allegations of Petitioner's conduct I've created and am running is @survivorsofalexnikolas on Instagram. I've been open about being the sole manager of this profile from the beginning because it was never a secret. I have mainly republished publicly available information. The only unique posts I've created there are artful memes that summarize the spirit of claims made against Petitioner. All other websites and profiles contain information I do not have means to have known prior to its publication.

Petitioner claims police came and that she was "injured" during "the harassment". Culver City Police came one time during protected activity on February 23 2023 and told me I had a right to assemble at the protest. Police

requested I stay away from Petitioner. I told them I already was and intended to continue to stay away from Petitioner. Police left without incident and documented the call placed by Michael Gray as Case Report 23-0001008.

In CH-100 7(3), Petitioner intentionally misinformed the court by referring to public protests as "[her] public appearances" to cast my protected conduct as "following".

Petitioner has no reason to fear me or Maurice [REDACTED] LAPI [REDACTED]. She is afraid of the consequences of other people learning about her conduct due to our investigative reporting and publications. This fear is justified and lawful. Good reporting will place wrongdoers in fear of exposure, while comforting those in the right that they will be vindicated. As a producer and journalist, I seek to expose wrong and vindicate right, and all activities I do as such are aimed at that purpose.

I have been unduly punished for expressing reasonable concerns about Petitioner, including her child's safety being in the home with poor hygiene and sanitation issues due to their pets not having regular access to relieve themselves in appropriate and safe places and about Petitioner's business and personal ethics (Exhibit 1, Exhibit 2, Exhibit 3) as well as Petitioner's capacity to safely maintain her position being publicly known as an "advocate" in delicate fields that she seemed less and less equipped to manage.

The only supported argument Petitioner makes is that she believes I am a different person than who I actually am. Everything else she has claimed is to embolden that narrative.

Petitioner self-diagnoses herself as having agoraphobia and anxiety without medical expert proof.

All my conduct, of the only few instances that exist, if engaged in at all, constitutes protected conduct under the US Constitution and State of California Constitution.

FURTHERMORE, the speech serves legitimate purpose in exposing and criticizing Petitioner's conduct toward survivors of sexual trauma since August 2022 and to inform the public of newsworthy conduct involving Petitioner and Petitioner's associates.

Petitioner has no evidence to support her claim that she had a conversation with me asking me not to "volunteer", nor does she have evidence of her claim that I was simply a "volunteer" for "her organization". In fact, her evidence supports my claim that we were discussing compensation for specific services and skills I provided per Petitioner's request.

I became aware of Petitioner in September on or around September 9 2022 when "Eat Predators", a protest group she was participatory in, gained media attention.

I met Petitioner directly in a group setting Online when she started a book club in the name of "Eat Predators" highly public "organization" brand, which at the time seemed to be a collective based on Petitioner's public claims that falsely advertised the purpose, nature, incorporation status/structure, and plans to the public in a way that specifically targets extremely vulnerable youth and adults, mainly between 18-40 years old. Petitioner

has used group settings, opportunities, and unsolicited — often obscene — stories to maliciously social engineer me and other people who have interest in societal “predators”.

Petitioner began maligning and exiling me from our mutual personal and professional communities after I informed Shelby [REDACTED] who I'd met in the "Eat Predators" "book club" that two of the "Eat Predators" "leadership" (Amanda [REDACTED], Leonila [REDACTED]) approached me with alarm that Petitioner told them she was planning to incorporate their collective as a for profit LLC. They were concerned about ethical problems due to internal and external expectations that "Eat Predators" incorporate as a not for profit business. Petitioner's husband had told me on November 8 2022, that he was going to pursue expedited for profit incorporation in his name or Petitioner's name a few days prior to Peters and Salinas contacting me with their concerns. I had expressed concern to Petitioner and her husband about the ethics of making decisions like that without getting input from parties with interest in "Eat Predators".

The conduct Petitioner cites as me being "aggressive" is not aggressive, but responsive. Conduct Petitioner believes is directed AT her is ABOUT newsworthy events she has strategized to orbit around her. All conduct Petitioner cited is constitutionally protected activity.

Petitioner cites no conduct where I've been "delusional", "crazed", or "obsessive" about anything especially her poorly formed "celebrity" status. I've had working relationships with public figures and participated in professional entertainment programs for years. I have a comprehensive published body of work that addresses my passionate goals to facilitate greater media and social literacy, especially amongst people with predisposition to

**GROUND 3: THE CONDUCT ALLEGED DID NOT OCCUR AS STATED IN THE PETITION.
FURTHERMORE, PETITIONER IS LYING ABOUT MATERIAL FACTS IN THE PETITION.**

Petitioner claims her "last correspondence" with me was November 16 2022. This is untrue. Petitioner called me on January 27 2023, 5 days after her first post to millions of people that I was "stalking" her. I reached out to established press at this time in hopes to vindicate myself to the public and impacted relationships in my personal and professional community with the truth. The only publication that supported me at the time was Crazy Days And Nights, a blind items publication run by an anonymous entertainment lawyer. (Exhibit 8a, Exhibit 8b)

This correspondence did not go as petitioner describes. Petitioner claimed the text she sent was an expression of anxiety about her experience with "Caeli" (Michaela [REDACTED]) having suddenly realized how the workflow had gone and what demands were being placed on her without priority on structure and boundaries within "leadership". We calmly discussed Petitioner's anxiety and I showed compassion as I suggested solutions to move forward without bringing past issues between other people into our exchange. Petitioner conveyed to me that she accepted this with seeming gratitude and grace. We ended the call with an expectation that I would send an email to Petitioner that summarized our discussion. I ultimately failed to complete and send the email. I had reached a limit on doing work and having conversations with Petitioner that were later disrespected or forgotten, and I wanted to ensure we were really on the same page before I spent more time drafting an email that may be a waste of my time. I called Petitioner to ask if we could have a follow up discussion. She did not

answer my call. She had not responded to my previous texts. I chose to stop reaching out and waited, only to be met with a concerted shunning and defamation led by Petitioner.

The last correspondences Petitioner tried to have with me were Online and over phone. Petitioner ignored my call and text, and instead sent a group message into our Slack asking for a meeting (Exhibit 4) with her poorly managed book club members who she was now using as mock leadership and labor. I did not respond to the group message. I decided to wait and see how the meeting fared without me since I felt my efforts and investments were being mishandled and demeanor. Petitioner had an emotional outburst and deleted the entire Slack (equivalent of shredding files and burning down the entire virtual office) then had the moderators of the "Eat Predators" Discord community ban me from our Online group, severing me from scheduled plans that did not involve her for a group call that very evening and a "friendsgiving" gathering Online a few days later. She told the group she was "scared" and began her first successful efforts to silo the group of psychologically vulnerable, mainly young adult fans of pop culture, into her captive audience of alarmed agents.

Petitioner claims her ex-husband (Milosh) is "the reason she started Eat Predators" when it's convenient, but she has also claimed that Johnny Depp, her child, and other justifications as "the reason". (Exhibit CCR podcast w timestamps)

Officer Garcia called Maurice. I did not send anything to the Petitioner. Officer Garcia told Maurice there was no criminal investigation being conducted on either me or him based on Petitioner's claims or for any other reason.

I have not been contacted by IG about any of the posts they're notifying Petitioner are alleged "violations". The last violation on the profile Petitioner brought into question that IG has notified me about was [date] The "violations" Petitioner submitted could be from any post. For all anyone knows, Petitioner could be reporting every post I make about anything.

I am absolutely unaware of what, if any, term or condition I could be violating because my posts have been arbitrarily disappearing — sometimes reappearing after hours or days — on my private Instagram profile @the_luciferous_shift since Petitioner began hyperfixating on the "image of her daughter" (Exhibit 5) and posted my information to solicit her base to target me with negative interactions. In less than 48 hours, I had over 95 people "request to follow" me on my private account, received several direct messages from hostile strangers (Exhibit 6), and suffered through dozens of people in my network unfollowing me. Some have been throttle blocking me, unblocking selectively to surveil my posts and act as self-appointed private investigators seeking the most easy to fashion threads of "evidence" that might pack stuffing in the entirely fictional strawman Petitioner has sold to the public and this court in my name.

I'm not a threat to anybody or their child. This photo was given to me consensually by Petitioner and permitted to be posted by Petitioner. Petitioner posted my original publication of this photo to her Instagram story. Additionally, Petitioner is aware of my work experience with families, as well as my expertise in pre- and perinatal psychology.

Petitioner is using smear and scare tactics that have been successful at stressing her out and that she has used on other people in her life that she wants to undermine and malign. Petitioner has rallied a cruel mob

I did repost the image to IG (and twitter and tiktok) with an explanation of the true events and the reel with 4 images and the audio track. I stand behind my choice, despite the frustration, fear, and fundamental violation of my humanity, rights, and personal/professional boundaries so many people I respect have committed me to.

When addressing my posts disappearing during this gangstalking, malicious social engineering, and celebration posts from my aggressor, my tone hasn't been "aggressive". It has been passionate, appalled, pained, and resolved to be heard. This is another instance of Petitioner using malicious social engineering to harm me.

Petitioner omitted information about the positive relationships to her, her husband, anyone I met in her life, and anyone in our mutual community.

Petitioner omitted information about terms of our agreements, such as money Petitioner and her husband agreed to reimburse me money I spent prior to me making purchases during my visit.

Petitioner description of stalking insinuates that I just appeared Online and in person on my own. I was invited by Petitioner to her home and encouraged by Petitioner to relate as a friend and colleague to her husband, her mother, and her friends and associates. She often introduced me as "a godsend". Her husband often referred to me as "Holy Shift". I felt uneasy about their exaggerated hyperbolic praise and was concerned the rhetoric would set me up to fail the expectations such inflated compliments might plant in the minds of the people they influence.

Petitioner claimed I talked about "being a gun owner to [her] in person". This is a blatant lie. I am very vocal about my lack of experience with guns and my desire to learn more about safe use and maintenance of firearms. I've discussed this publicly for years and I talked vulnerably about it in person with Petitioner and Petitioner's husband.

Furthermore, Petitioner included a screenshot of an excerpt from a poem I wrote and posted just after Petitioner suddenly deleted the virtual workspace she had made immediately upon my recommendation to consider it during an "organizer meeting". Petitioner had asked for a meeting in which a few agenda items included integrating my offer to suggest tools and resources to remedy neglected organizational communication and operations.

Petitioner claims she believes I am "following" her. The only instances cited as "following" You should say you follow the movement and regularly report on it. have been when I have assembled and handed out literature that I prepared to speak for me and my colleagues at public protests where I have been polite, mainly quiet and at a distance unless spoken to or explaining literature I'm distributing, and vigilant to remain in adherence of law. Cite the law that permits you to be there. During the protest at which I was served with this case, I was never within 100 yards of Petitioner or any other protestors besides Maurice ██████████ except when Melanie and Sloan walked 100+ yards, from out of sight, to scare and serve me, and when I arrived — and when I left since they trapped me on a dead end road when they "served" me. Petitioner used this court to justify menacing me with two agents to get in my face despite being approved for free service from the Sheriff due to the nature of her claims.

Furthermore, Petitioner's choice to use my legal first name throughout the description is odd, overly personal, and unwarranted.

Petitioner's false claims against me began on Twitter and Instagram, alerting over 250k strangers on the internet to her lies about me.

Her first public claims about a "stalker" began on Jan 23 2023 — mere days after I released an episode of my show where I hosted 2 original founders of Eat Predators, the protest group Petitioner has misinformed the court about in this case. (Exhibit 13)

Petitioner's description of harassment in 7a(3) is alarming. This court has done its job well in responding to this alarming story by issuing a TRO. Unfortunately, the description is a false, deluded perjury. Petitioner has intentionally obscured the timeline and nature of our interactions, as well as my posts.

Petitioner has often used alarming words like "obsessive", "delusional", "crazed" inappropriately.

Inconsistencies with description that include use of word "demonstration" for the regular unpermitted public protests Petitioner habitually stages protests directed at individuals and businesses. Since excommunicating Petitioner habitually the original founders of Eat Predators and me, she has reduced the scope of the brand to exclusively protests, social media groups, and repeating Petitioner's messaging. It is unclear whether Petitioner purposefully concealed the nature of these events to the court in her claims. All instances Petitioner claims I was "stalking" or "following" her were either locations and times I was directly and personally invited to by Petitioner or public protests and only attended to exercise my freedoms and liberties. I have never "followed" or "stalked" Petitioner at a "public appearance".

insinuation that I was asserting that she or any person is in reference as an "idol" to my use of the term "kill your idols" that was misquoted in paragraph 1 of attachment 7a(3) No 2. The true meaning of "kill your idols" is to subject even one's highest artistic inspiration to criticism, "killing" the "idol" status of the inspiration by treating them as fallible and mortal. A reasonable person who is as artistically accomplished as Petitioner reasonably should know this.

Plaintiff description misquotes me by jumbling transcriptions and timeline of events, as well as selectively omitting any mention of my public and media relations work I provided per her request and demand. I did some volunteer work for "Eat Predators", but I also provided much more than that in service to Petitioner per her request on verbal cot. Petitioner's description of "harassment" seems to surgically extract any mention of any mutual friendliness or appreciation. Petitioner and her husband also never reimbursed me as agreed upon for specific items, including urgently needed batteries for their megaphone and food for the protest group at Erewhon; toilet paper, paper towel, and organic milk for their home; a nice headset with mic for podcasting and meetings; and food and beverages. Petitioner's husband was insisting they would reimburse me for these things, received my Cashapp information, then cut me off without a word. They also refused to return belongings I accidentally left at their house when I was anticipating returning in a couple of weeks.

One of the offers I made to Petitioner and her husband was career coaching. I have specific experience in creative career coaching, especially writing and visual services. Petitioner and her husband graciously and generously accepted my offer but did not follow through with scheduling, despite my numerous gentle

reminders. One of the reasons I was confused and shocked about Petitioner's sudden generalized idea to put compensated work on hold was that part of my expected work was supporting Petitioner's income, Petitioner's husband's income, and strategizing potential revenue options for "Eat Predators".

"Eat Predators" was a poorly managed, falsely advertised collective with confusing purposes that was co-opted from collective leadership by Petitioner and her husband. Petitioner was central to many complaints brought up by leadership in "Eat Predators" which had no incorporation structure.

I do not and never have lived or stayed in Burbank.

I've been concerned for my safety and wellbeing due to Petitioner's fixation on me and my content in effort to embolden her warped narrative about me. She has gone to appalling and terrifying lengths to divert attention from the episode of my show that triggered her undue petition for me to be restrained by order of the court.

Petitioners claim to have a count of posts and hours of audio and video that she believes are about her are outlandish and may include anything I've ever posted, replied to, or included hashtags that may be regarding her, Eat Predators, any of the book club, discord, or tangential people or communities. This is an attempt to control my speech, opinions, and actions.

Petitioner claims to have a belief that I am "obsessed" and "crazed" in regard to her, therefore I have to assume this detailed calculation of my content may include posts and productions that occurred when our relationship was positive and supportive. My first episode publicly promoting Eat Predators was released on November 8 2022, the day I left from my pre-move visit to Los Angeles to return to Sonoma County, where I was living. Petitioner and many people in her social ecosystem (including fan accounts) have begun to aggressively throw around use of my home county, Marin, which is near where I had been living prior to moving to Los Angeles but is not where I was living. Due to the nature of the false claims and volume of psychologically diverse individuals in Petitioner's social ecosystem, I fear for my own life as well as the lives of anyone in any location I've ever lived, received mail, or been publicly associated with in any way. I have no means to seek protection for the most vulnerable people in my life that the petitioner has put in danger by making false statements about me and encouraging her fans to rally concern about me.

Finally, in all the detailed scouring of my content, Petitioner has omitted any mention of my skill, professional experience, talent, and legacy goals. Petitioner has been maligning me and misleading her supporters by obscuring my creative capacity, and that of my extraordinarily talented associate, Maurice, who has been the only member of my network brave enough to also speak out against Petitioner's unlawful and unethical activity.

Petitioner has submitted a heaping, steamy pile of perjury to this court. All of this public outcry and malicious litigation was triggered by one thing that the Petitioner has surgically extracted from her description of "harassment" and "stalking" — the Good Morning Mayberry episode "The Real And True Origin Story of Eat Predators". The episode was released on January 19. Her scare campaign — which she is seeking to reinforce with this plea to the court — launched at me on January 23, as a major public announcement to her 260,000+ social media "followers".

Because of the way anti-slapp laws were used in cases involving her and Michael Milosh, Petitioner has been drunk with a perceived power to disillusion any audience — including this court — with impunity.

This is all about Petitioner having her next publicity stunt.

Petitioner's defamatory and dangerous posts directed at me have been the most engagement she's ever gotten. Compared to her other topics of interest, her posts about me have garnered her more attention and opportunities than any of her other posts about any other topic or person ever, including Britney Spears. I am terrified and appalled at the lengths Petitioner has gone to to distract the entire world — her community, our mutual communities, the public, and this court — from the simple realities brought to light in the episode I released and promoted at the protest at Tristar on January 19 2023 (Exhibit 14?????????).

All texts Petitioner submitted have been surgically carved to eliminate any evidence of love, respect, shreds of my true nature, or even my basic humanity.

Petitioner, her husband, Melanie ██████████ entrapment by restraining order by staging Petitioner near my vehicle, having

Petitioner invited me into her home and with her family. Petitioner took the photo of me and her daughter. Petitioner encouraged me to have a relationship with her family, including her daughter. Petitioner suddenly and harshly ceased all communication with no explanation or request for me to stop working or stop contacting her. I chose to stop reaching out to her and her community because I was sad and confused by Petitioner's choice. I've only maintained relationships with people I met in the "Eat Predators" community who have clearly sought mutually honoring relationships with me.

After we started working together Petitioner became unreasonable and evasive when I questioned her business ethics and capacity to lead. Petitioner suddenly cut me off after I expressed concerns to 2 members (Exhibit 2) of Petitioner's book club who were being courted for "leadership" positions and told them to feel free to use their discernment in conveying my concerns or holding them in confidence.

My primary concern came after Petitioner signed with UTA for management and then told me she was aware that Bryan Friedman is their lawyer. She had pushed the group into several protests that targeted Friedman, so I was concerned about Petitioner inviting a purposeless conflict of interest and in turn forcing her loose ethics on the collective.

Furthermore, my first contact with "Eat Predators" was not the Petitioner. It was Amanda ██████████ who, like Petitioner, is (or was) represented by Jeff Anderson and Associates in a high profile case. ██████████ and I developed a fast friendship Online and Peters had encouraged me to meet Petitioner. ██████████ participated in many in person activities with Petitioner, including public protests. When I met Petitioner, she had recently begun shunning Michaela ██████████ from the group. Petitioner told me on or around November 20 2022 that she "[does] not trust Amanda" but could not explain why. I was never able to decipher any reasonable justification for that comment, but I believe it had to do with ██████████ refusing to report ██████████' conduct to Petitioner per Petitioner's demand.

Petitioner and her husband stopped responding to any of my messages or calls after I joyfully and casually informed them that I had recorded an episode of my show with Peters and was excited to begin editing to publish positive press for "Eat Predators".

Petitioner removed me from the group under false pretenses in an effort to silo her young fans from even the slightest criticism about her. Petitioner first lied to the group, then the public, and now she has lied to this court.

After I was suddenly banned and shunned, I declared I would publish information about the "trauma dumping" from "the past 2 weeks", which denotes the time I was in Los Angeles being dumped on with Petitioner's erratic and stressful ideals. Petitioner scaremongered the young people in Eat Predators group to make them think I was going to share private information they'd conveyed under presumed confidence when I had clearly described informing them and the public about Petitioner's irresponsible and disrespectful use of my time and energy.

Petitioner has assumed I was talking about her when I reference other people, "the universe", myself, my goals, the poetic phrase "kill your idols" (which has been commonly used for decades to sober people from disillusionment), and other highly things that have little or nothing to do with her directly. Petitioner seems unable to distinguish between herself and her supporters, initiatives and movements that have existed long before her recent emergence into tabloid news, and other things that seem random to me. Petitioner seems unable to distinguish between me and other people, citing Maurice's words and actions as though I am committing them. Petitioner's description of Maurice is deeply unsettling and seems to caricature him as an appendage, puppet, or parasitic twin. It is unclear if she means to be so dehumanizing and oppressive to a talented and beautiful creative journalist. Petitioner's crazed agenda got Maurice thrown in handcuffs for the first time in his life.

Neither Maurice nor I have any criminal records whatsoever. We plan to keep it that way. We are law-abiding citizens of the United States who have been maligned in this case.

I must stress again that Maurice and I are two distinct people. We met in fall of 2022 [episode w timestamps] and have become close friends and cherished colleagues since our initial meeting.

I have no ill will toward the Petitioner, in fact, I pray for her to find healing and ethical ambition as I continue to report on the facts about her misuse of her position of power in the Eat Predators "organization" and her willful misdirection of the "organization" and many movements and initiatives it impacts. I will also continue to be a highly expressive, levity anchored, integrity driven, somewhat silly, maybe too smart and too dumb for my own good media producer and public figure in my own way.

My real name is Shift Hailey-McMurray. There were enough identifying details for many people to recognize her posts were about me, and contact me about it within hours. I've also been informed by mutual acquaintances that she is telling people I'm "WILL." Although the pseudonym she chose for me was apparently derived from the villain of a book we had recently read together in a book club, William is also the name of my deceased father who Alexa and I had talked about several times, and she had seen tattooed on my arm when I was a guest in her home for 5 days.

I have never stalked, harassed, or abused Alexa in any way, shape or form, and I can prove it. The "receipts" she posted on Instagram do not show any evidence of stalking, obsession, or threats. I'm not a threat to anyone but unapologetic abusers. I'm actually a whistle-blower that she is seeking to discredit using horrifying alarmist defamation, triggering survivors who look to her "activist" platform for hope and inspiration.


Over the past six months, she has garnered a lot of media attention for her involvement in the protest group "Eat Predators." The short story is that Alexa has fabricated a narrative of false and criminal accusations to attack me for producing an episode hosting two former members of Eat Predators' leadership on my podcast, 'Good Morning Mayberry.' They describe her mistreating

survivors while co-opting the original activist collective after their Nickelodeon protest generated a lot of press. I also shared my experience feeling exploited by Alexa after making a verbal agreement to work for her, under the impression that I would be compensated. She never paid me for my labor and 'ghosted' me after I tried to gently discuss my concerns.

After I released the podcast, she began a smear campaign. Then, someone I don't know launched a website that claims to have evidence of criminal and unethical behavior involving Alexa, dating back many years before I'd even heard of her. I became aware of this website after a source alerted me to it and a Twitter account dedicated to exposing Alexa's past behavior started tweeting about her regularly for the last week, since her smear campaign began. The Twitter account appears to be run by the same person who set up the website. I've also been contacted by other people who have claims that they and people they know have been harmed by Alexa in similar and bizarre ways, dating back to her youth and involving behaviors like cyber crime, sex crime, harassment, enlisting underlings, targeting these people's loved ones, manipulating young people, physical stalking and trespassing, filing false police reports, and strategically weaponized false accusations.

In her defamatory posts about me, I saw comments calling for doxxing, arrest, and general lynching of the person she's weaponizing her fanbase (her Instagram following is about 265,000) to mobilize after. I've also seen many survivors who've actually been stalked, harassed, and deceived are triggered to be protective of her. As a survivor, this alarms and saddens me. People may be more attuned to her posts because it's Stalking Awareness Month. Many of the people who have interacted with her are afraid to speak about their experiences. As a whistle-blower who has been subjected to Alexa's warped wrath, I can understand why. She's put me in quite a dangerous position -- especially as a queer person of color -- all to avoid addressing any of our grievances or attempts to privately resolve what we'd thought were relatively typical problems.



Can we Eat Predators if we are what we eat?

Kay (Four 4 Consent, Nightlife Safety Summit) and Caeli (Music Industry Watchdog) join Shift Orion to describe the origins of the Eat Predators collective and how the brand was co-opted as they were driven out... just before Shift discovered it on social media, joined the unregulated Eat Predators Book Club, and hauled his ass from SF to LA to help the mysteriously misrepresented "leadership" lock down a business strategy.

Caeli and Kay detail their experience forming Eat Predators alongside other survivors and organizers like Nomi Abadi, Sochil Martin, and Alexa Nikolas.

They cover the first planning meetings, escalating miscommunication and misrepresentation accelerated by media attention from a nearly-off-brand protest at Nickelodeon, and challenges navigating interpersonal and professional conflicts as the group (and Alexa's wounded ego) grew faster than anyone (except people who've been crushed by it) could imagine. As the media and public began to exclusively center and sensationalize Alexa, her participation and story have warped.

Shift describes his experience getting into the "Eat Predators book club" (then finding out it was never supposed to exist), having a short-lived but intense friendship with Alexa (and an even shorter-lived role working as her media and public relations manager), and being shocked and heartbroken discovering that Alexa had misled him about everything. Opening up about getting to know her remotely then planning an in-person visit, even staying at Alexa's house for 5 days, Shift recalls how quickly Alexa's endearing personality turned hostile after he became concerned about her capacity and ethics as she orchestrated the book club community and other people to shun him by making alarming and untrue claims.

Ultimately, the conversation remains loving and generous with hope for accountability, amends, and honesty to prevail.

Last year, 2022, was a year of triumph for Alexa Nikolas. She was awarded the "PAVE Inspiration Award" for her high profile activism in the fight for survivors of sexual assault.


