

- 3.4 To undertake and arrange for publishing booklets, articles and books for promoting Education and educate people through hoardings, advertisements, exhibitions and seminars.



8. The day to day works and substantial powers of Board of Trustee will be vested Manoj Kumar Singh S/O R.N.Singh, resident of 145, Avas Vikas colony, shahpur District/Post office - Gorakhpur and he shall be designated as "Managing Trustee" (PRESIDENT)
9. In the matter of investment of Trust funds, the provision of section of the Indian Trust Act 1882 shall apply.
10. The Trustees shall be accountable only for such moneys, stocks, shares and funds, which will actually come into their hands and a trustee shall not be answerable or accountable for neglect, default acts or omission or commission of the other trustees, nor of any broker or other person with whom the trust properties or any securities may have been deposited or kept.

13. It is expressly declared that no part of the Trust property or its income or any assets thereto shall be applied for any purpose outside India or for any purpose which is not a charitable purpose in law and all provisions hereof shall be construed accordingly.
14. The office of the Trust shall be situated at Pandey Complex, Infront of Dig Bunglow 33 Kasaya Raod Bilandpur Gorakhpur U.P. unless changed by the two-thirds majority of the trustees.
15. The Trustees shall have the power to determine in case of doubt whether any money or property shall for the purpose of the charity be considered as capital or income and whether out of income or capital any expenses or outgoing ought to be paid or borne and every such determination shall be

16. POWER AND FUNCTION OF THE GOVERNING BODY

- To administer and control the affairs and funds of the Trust and exercise all power of the Trust in order to fulfill the aims and objects of the Trust.
- To purchase take on lease or in exchange or hire or otherwise acquire any movable or immovable property for the purpose of the Trust and to carry out agreement, loan, grants and other assistance in suitable terms.
- To fill the vacancy created by resignation or removal of trustee within three months of the occurrence of such vacancies by appointing any trustee as per clause 12 of this trust deed.
- To fill the vacancy created by death within three month of the occurrence of such vacancies by appointing any one of the family members of the deceased trustee.

17. MEETING OF THE GOVERNING BODY

- The meeting of the Governing body shall be held at such time and place as the Managing Trustee may decide from time to time.

- (b) A meeting of the Governing Body may at any time be called by the Managing Trustee at the written request of two third members of the Governing Body.
- (c) All the meeting of the Governing Body shall be presided over by the Chairman and in his absence by any one of the Directors authorised by the Chairman
- (d) The annual meeting shall be held normally within four months and not latter than six months after the closing of the financial year. Not more than fifteen months shall elapse between consecutive annual general meetings.
- (e) Question arising at a meeting shall be declared by a majority of votes but in case of equality of votes Chairman shall have second and casting vote.
- (f) The Governing body shall meet as often as necessary but at least once in every calendar quarter at such place and time as the Chairman may decide. The Managing Trustee will send the notice and agenda of these meetings to all members of the Governing Body at least fifteen days before the date fixed for the meeting. The quorum for the meeting shall be two third subject to minimum two trustees.
- (g) Whenever the Chairman is of the opinion that a special meeting of the Governing Body is to be called to discuss and decide an urgent matter of shorter duration the Chairman and any one of the Directors will form



- (f) To open account in the name of the Trust, with a Bank or Banks, to operate such account and to give instructions to the Bank and to provide for opening and operation of such account by one or more of the Trustees or by an agent appointed by the Trustees.
- (g) To engage or make provision for the engagement of any person (including all or any of the Trustees and committees or administrator or Managing Trustees or otherwise) for the purpose of the administration of the Trust in such rules and regulation as the Trustees may prescribe and also to engage or provide for the engagement.
- (h) To make, vary, alter or modify schemes, rules and regulations for carrying out the objects of the Trust and for the management of the affairs thereof and /or running any institution in furtherance of the objects of the Trust and otherwise for giving effect to the objects of the Trust.

- (l) To borrow moneys either on the security of any property comprised in the Trust Fund or otherwise for all or any of the purpose of these presents, and it shall be lawful for the trustee to make such borrowings on payment of such interest and otherwise on such terms and conditions as they may in their absolute discretion think fit.



- (q) Whenever the seal of the Trust is to be affixed to any writing deed or document executed by the Trust the same shall be affixed in the presence of persons executing the document. The seal of the Trust shall not be affixed except under the authority of a resolution of the Governing Body.


