## 2. THE PROBLEM: THE HIDDEN COST OF STRUCTURAL INCOMPATIBILITY

Brazil requires foreign documents to make sense in light of local law to be registered.

The Result: The registration process stalls at Commercial Registries (Juntas Comerciais) and Notary Offices, generating endless requirements. This delays obtaining a CNPJ (tax ID), opening bank accounts, and starting effective operations by months.

## 2. THE PROBLEM: THE HIDDEN COST OF STRUCTURAL INCOMPATIBILITY

- The U.S. Order: Is valid in the U.S. but is a "mere piece of paper" to Brazilian local police or authorities.
- The Brazilian Reality: Without STJ ratification, the father can claim he still holds full parental rights under Brazilian law, as the U.S. order hasn't been "domesticated."

### 2. Erosion of Limited Liability

The concept of "limited liability" and the protection of the "corporate veil" are robust in the U.S. In Brazil, however, the judiciary, especially in labor and tax spheres, tends to disregard the legal entity (piercing the corporate veil) more easily to reach the partners' assets.

- **The Risk:** If the structure of the U.S. parent company is not accurately reflected with technical precision in the Brazilian constitutive acts (Articles of Association/Contrato Social), partners or the U.S. headquarters may be exposed to Brazilian liabilities in ways they did not plan for and which would be unthinkable in their home jurisdiction.

### 3. The U.S. LLC "Limbo" in Brazil

A U.S. LLC is a hybrid entity offering the corporate protection of a corporation but with the tax flexibility of a pass-through entity (similar to a partnership). The Brazilian tax system struggles to classify this figure: should it be treated as a "society of persons" or a "society of capital"?

- **The Impact:** An incorrect classification by the Brazilian Federal Revenue Service (Receita Federal) can lead to disastrous double taxation on the remittance of profits or dividends to the U.S., rendering the business model unviable.

### 4. Ineffective Corporate Governance

U.S. governance structures, such as Boards of Directors, Officers, and Managers, must be carefully adapted to the concepts of Administradores (Administrators), Diretores (Directors), and Conselheiros (Council Members) provided for in Brazilian Corporation Law or the Civil Code. Ignoring this adaptation stalls decision-making, legal representation, and the ability to sign contracts within the country.
