Vendor Fee Structure & Payment Policies – 2026 Season

To support the organization, promotion, and sustainability of **Raíces Locales Farmers Market**, the following vendor fee and payment policies apply to all vendors participating in the 2026 market season.

These guidelines help ensure a well-organized marketplace while maintaining a fair and transparent process for all participating farmers, artisans, and entrepreneurs.

2026 Market Dates

The Raíces Locales Farmers Market will take place on the following dates:

- **April 25, 2026 — Grand Opening**
- **May 30, 2026**
- **June 27, 2026**
- **July 25, 2026**
- **August 29, 2026**

Vendors may apply to participate in one, multiple, or all market dates depending on availability.

Vendor Fees

The following vendor fees apply for the 2026 Raíces Locales Farmers Market season:

Grand Opening Market

April 25, 2026

Vendor Fee: **\$80 per vendor**

This special rate celebrates the **Grand Opening of Raíces Locales Farmers Market** and supports the launch of the community marketplace.



Regular Market Dates

The following dates apply the standard vendor fee:

- May 30, 2026
- June 27, 2026
- July 25, 2026
- August 29, 2026

Vendor Fee: **\$100 per vendor per market date**

Foodtruck Fee: **\$350 per market date**

Payment Policy

Vendor space reservations are confirmed **only after payment has been received**.

Payments must be submitted within the timeframe communicated after vendor approval in order to secure the vendor space for the selected market date(s).

Vendors who have not completed payment may not be permitted to participate until the required fee has been received.

Payment Method

Vendor payments can be completed through **Zelle** or through the **secure payment button/link provided during the vendor application process**.

Once a vendor application has been approved, vendors will receive confirmation and instructions to complete payment using one of the available methods.

Payments should include:

- Vendor Name
- Business Name (if applicable)
- Market Date(s) selected

This ensures proper registration, payment verification, and booth assignment.



Vendor Space Confirmation

Vendor spaces are considered **confirmed only once payment has been received and verified.**

Due to limited vendor capacity, spaces are assigned on a **first approved and paid basis.**

Refund Policy

Vendor fees are **non-refundable** once payment has been submitted.

However, if a vendor cannot attend a confirmed market date, organizers may consider transferring the vendor's participation to another available market date within the 2026 season when possible.

Requests must be submitted in advance and are subject to availability.

Vendor Responsibilities

All vendors must comply with the Raíces Locales Farmers Market guidelines, including:

- Selling approved products listed in the vendor application
 - Maintaining a clean and safe booth space
 - Respecting a family-friendly and community-focused market environment
 - Complying with any applicable food safety or business regulations
