There appears to be **no published ACOBA advice** for either of the following roles:

- 1. His position on the Public Interest Body (PIB) of PwC UK, and
- 2. His concurrent or subsequent position as **Non-Executive Director at the United Kingdom Accreditation Service** (UKAS)—a body that was under his former departmental remit.

#### **Key Issues:**

- Dr Rycroft left Crown service in March 2019.
- Archived LinkedIn records previously listed his start date at PwC as March 2019-the same month he left public office.
- That date was later changed to March 2020, which did not remove the role from ACOBA's jurisdiction, but appears
  to reduce the visible overlap. The role still falls well within the two-year restriction period.
- No public ACOBA advice or clearance has been located for either PwC or UKAS.
- PwC is certified by and engages regularly with BSI (British Standards Institution), which is accredited by UKAS. Dr Rycroft's governance roles at both PwC and UKAS therefore present unresolved conflicts of interest, particularly under ISO/IEC 17011 Clause 4.4.6 which requires UKAS to monitor and treat board-level impartiality risks.

## **Broader Governance Context:**

This concern is heightened by similar issues involving **Lord Harrington**, who moved from ministerial office (DLUHC, 2022) into a role at **Stephenson Harwood LLP**. ACOBA has also confirmed **no record of prior approval** for that appointment.

You contacted the Advisory Committee on Business Appointments (ACOBA) under the Freedom of Information Act 2000 to request the information ACOBA hold on whether:

- 1. Dr Philip Rycroft CBE (former Permanent Secretary at DExEU) sought or obtained approval for appointments with:
  - a. the Public Interest Body of PwC UK
- b. the United Kingdom Accreditation Service (UKAS), as a Non-Executive Director.
- 2. ACOBA will investigate inconsistencies around Dr Rycroft's start date with PwC start date, as you told ACOBA there were archived LinkedIn records previously listing his s
- 3. ACOBA considers retrospective publication or findings are appropriate in light of ongoing regulatory and legal consequences

#### ACOBA's response

I can confirm that ACOBA does hold information relevant to your request. I have responded to the three questions raised below:

#### 1. Did Dr Rycroft receive advice?

Dr Rycroft sought and received advice from ACOBA to work with both the Public Interest Body of PwC and as a board member of UKAS.

The advice letter sent to Dr Rycroft for UKAS is published on the <u>ACOBA pages of gov.uk</u> and are therefore in the public domain. Therefore, pursuant to section 21(1) of the Freed Act), this information is exempt because it is reasonably accessible. For ease of access, I have included the link to the advice letter

#### 2. Will ACOBA investigate inconsistencies regarding Dr Rycrift's start date at PwC - which you said appear in archived LinkedIn data?

Having looked into the information held and the information available in the public domain ACOBA has found no evidence of inconsistency. Our records show that Dr Rycroft told *I* post after receiving final advice, though no firm date was provided. He was provided with final advice in February 2020. Publicly available records show that PWC's website records beginning in March 2020; as do the available LinkedIn pages.

#### 3. Will ACOBA consider retrospective publication or findings appropriate?

ACOBA is committed to transparency and considers it is in the public interest to make public whether or not individuals have complied with the government's Business Appointmen As it has come to our attention now that Dr Rycroft took up the position with PwC in March 2020 but the advice was not published, we have now updated Dr Rycroft's page on ACC https://assets.publishing.service.gov.uk/media/6824b6517293a87b6c75ec5VeC/uce\_letter\_\_\_Philip\_Rycroft\_\_Independent\_Non-Executive\_\_PwC.pdf. As above, pursuant to sectin Information Act 2000 (the Act), this information is exempt because it is reasonably accessible.
