Foundation and Establishment of Mission (2018 – 2024)

Unlike traditional litigation, arbitration is a non-judicial process, and the parties involved agree on the arbitrators who will decide the outcome of the dispute. The award issued by the arbitrators has the force of law and can be enforced like any court judgment.

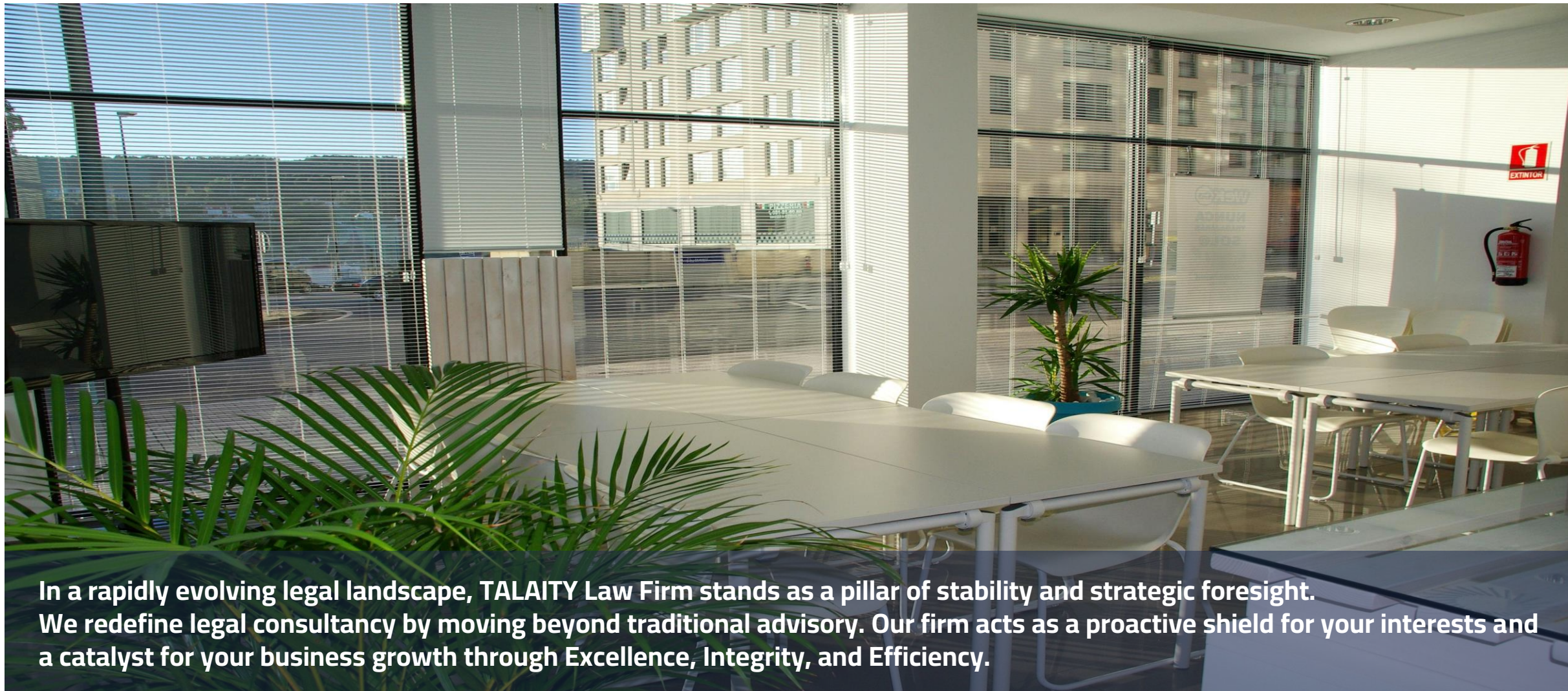
