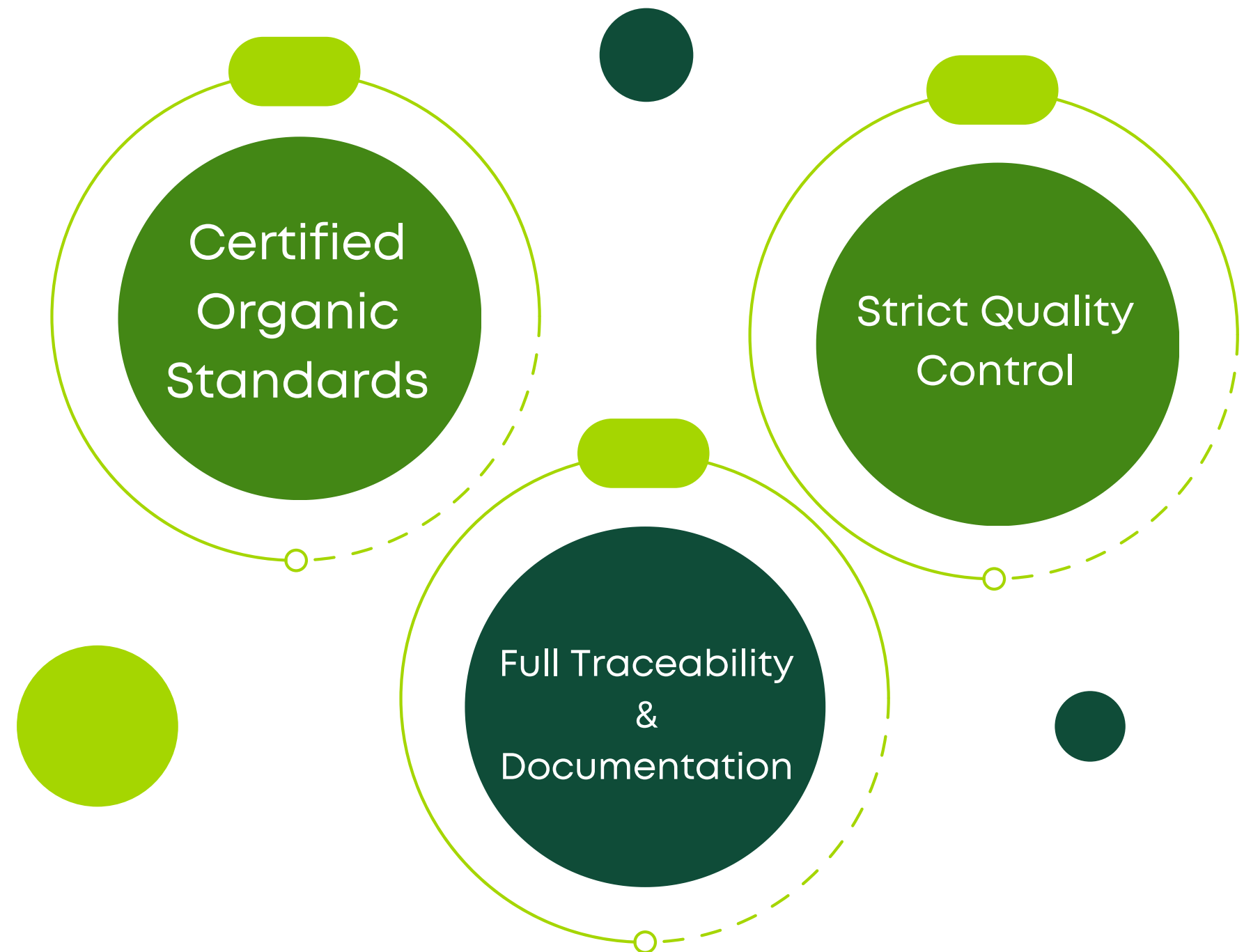

Certified for exporting agricultural products, ensuring that all our products meet the required health and safety standards for global markets.

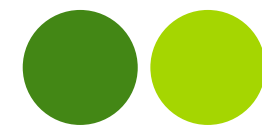
