

- December will be the last month cutting grass along the subdivision. The 2024 schedule will commence promptly in April 2024.
- While the pools are closed for the season, work will be completed at the main deck and adjacent areas.
- All the gravel roads will be graded and limestone added as needed. We are in a transition period of replacing the gravel to limestone which will compact better and reduces maintenance.
- Safety has been one of the major concerns. There is a high percentage of resident and vendors that don't maintain the speed limits.
- Residents and vendors (Amazon) are continuously entering the wrong way at one-way streets along Fay Way and Poupee'.
- The number of children playing and walking along Mayer's Trace has increased, therefore we need to be more vigilant and cautious about speeders. You can help reporting these incidents with a picture of the license plate if possible.
- The burn ban has been lifted, be sure that you are vigilant when burning and don't leave the fire unattended
- Please send any issues with trees or anything related to the common grounds or architectural committee to my email address or you can text me. I need your communication in writing. This is how I keep a record of items that need to be addressed.
- We continue to wait for repairs to be made to the small bridge in the back of the subdivision. The

- Dead trees continue to be removed to retain the safety of the subdivision.
