### Health and Safety Risk Assessment – Der Stumpf Live Events

#### Overview

Der Stumpf is a live event featuring a physical skill-based game involving two players using hammers to drive nails into a log. The setup includes strict safety protocols to protect both players and spectators.

#### **Identified Hazards & Controls**

### **Additional Safety Procedures**

The referee is trained in both the rules of the game and essential safety monitoring.

The event area is clearly demarcated with barriers to prevent accidental entry by the public.

Equipment (hammers and nails) is standardized and supplied by Der Stumpf to ensure safety and consistency.

All players receive a briefing on safety rules before participation.

A first aid kit and designated first aider are present on-site during all events.

Hammer mis-use or uncontrolled swings	Players, Referee	Players are required to use a disciplined, one-piece strike. No part of the hammer may go above nose height. Referee monitors form at all times.		
Flying nails or nail fragments	Players, Spectators	Nails are stainless steel, reducing the likelihood of shattering. Referee uses a gauge to pre-insert nails 35mm into log to prevent dislodgement.	LOW	
Hammer slipping or being thrown	Players, Spectators	All hammers are tethered to the log to prevent dislodgement or accidental projection.	LOW	
Unauthorized access to arena	Players, Spectators	Only two players and one qualified referee are allowed inside the playing arena.	LOW	
Proximity of spectators to activity	Players, Spectators	A barrier is installed at least 2 metres from the log to maintain safe distance from play.	LOW	
Incorrect nail placement	Players, Spectators	The referee is solely responsible for hammering in all nails using a measuring gauge.	LOW	
Inadequate supervision or response	All present	Each game is overseen by a qualified referee trained in enforcing safety and managing incidents.	LOW

#### **Additional Safety Considerations**

Der Stumpf takes place at festivals where alcohol is served. The referee is responsible for monitoring players for signs of excessive alcohol or drug use and may remove any participant from play if they are deemed unfit to safely take part in the activity.

Although the activity is considered low risk due to stringent safety measures, safety glasses are available for players who wish to wear them. Their use is optional and left to the discretion of the participants.

### Conclusion

With the above safety measures rigorously applied and enforced, Der Stumpf presents a low risk to both participants and spectators. Ongoing monitoring by trained referees and controlled access to the arena further mitigates potential hazards.
