## **Procurement Procedure**

### **Buyer's Perspective (Structured | Transparent | Physically Verifiable)**

**Invitation to Buyer:** The Buyer is formally invited to visit the Principal Seller's office, mills, refineries, warehouses & load ports for physical inspection and verification of the Seller, producers, facilities & operational readiness prior to execution after issuance of the Payment Guarantee.

#### **◆ Transaction Flow:**


- **Compliance Exchange:** Mutual exchange of CIS / KYC documents.
- **RFQ Submission:** Buyer submits RFQ to obtain a quotation directly from the Principal Seller. No FCO / SCO issued.
- **Commercial Alignment:** Upon agreement on price & procedure, Buyer issues LOI / PO to obtain a Draft SPA.
- **Standard Fund Verification:** Buyer provides proof of financial capability via MT-199 SWIFT / RWA.
- **Instrument Verbiage Review:** Submission of SBLC or Irrevocable, Divisible, Transferable & Confirmed LC verbiage copy.
- ✓ Top-tier banks only.
- ✗ No leased instruments accepted.

**SPA Execution:** Formal execution of the Sales & Purchase Agreement (SPA).







#### **🔒 Payment Guarantee Structure:**

- Buyer issues SBLC or Irrevocable, Divisible, Transferable & Confirmed LC.
- ✗ Non-transferable DLC/LC not accepted due to cost inefficiencies.
- ✓ Transferable LC issued in Seller's name and transferred to mills/refineries/producers to optimize cost & execution efficiency.


### **Payment Terms:**

- Payment at load port via MT-103 / TT within 72 working hours.
-  Vessel release strictly upon receipt of payment.

### ◆ **Logistics & Execution:**

-  **Cargo Loading:** Within 15–25 business days from financial instrument activation.
-  **Shipping Documentation:** Issuance of complete and clean shipping documents.
-  **Inspection:** SGS conducts Quality & Quantity (Q&Q) inspection at the load port.
-  **Final Payment Confirmation:** Payment confirmation at loading port within 72 hours.
-  **Cargo Discharge:** Cargo discharged at destination only after payment at the load port.
-  **Subsequent Shipments:** Continuation of shipments strictly as per SPA terms.
