PURPOSE OF THE AGREEMENT FOR SERVICES

The purpose of this contractual agreement for Prime Party Rentals, LLC, to provide rental services and equipment for short-term use/rental. The following services, including transport, installation, set-up, take-down and retrieval will be provided.

SCOPE OF SERVICES (check all that apply)

Prime Party Rentals, LLC will provide inflatables, water inflatables, and all necessary equipment for the function of the inflatable/s and/or water inflatable/s including extension cords, excluding electricity supply and water supply for temporary rental. In the case of lack of access to electricity or an electricity malfunction, Prime Pary Rentals, LLC, may supply stand-alone generated power.

Prime Party Rentals, LLC will provide tables, chairs, tents, linens, and/or other party supplies.

Prime Party Rentals, LLC will be responsible for transport, installation, set-up, take down and removal of all rental items.

_____ shall agree to indemnify and hold harmless Prime Party Rentals, LLC, its Agents/assigns and/or employees for any all claims, losses, judgments, attorney fees, costs, damages, injury or other monetary loss of liability except to the extent caused by gross negligence or willful misconduct of Prime Party Rentals, LLC, its Agents, assigns or employees. _____ has thoroughly read, understands, acknowledges, and confirms that they are giving up legal rights to seek legal action or demand for conduct, actions, circumstances, claims, losses, damages as herein described in this paragraph. _____ hereby agrees that any guests that they host to use said equipment are subject to this hold harmless agreement and are the sole responsibility of the Lessee/Renter/User. Lessee/Renter/User understands that the use of such equipment could involve inherent risks, including but not limited to, physical injury, death, or property damage. Lessee/Renter/User acknowledges such risks and takes full responsibility to ensure that all possible precautions are taken to avoid injury to people or damage to property/equipment. Lessee/Renter/User agrees that he/she/they has/have read, understand and signed this Contractual Agreement and Liability Waiver and fully accepts responsibility for all inherent risks, whether known or unknown, of the use of said equipment.

The normal use of inflatables, including water inflatables and equipment, requires passage through property and use of property to get to a water source or electricity source or the location where the inflatables/equipment shall be used. Lessee/Renter/User agrees to indemnify and hold harmless Prime Party Rentals, LLC for any damage or loss caused by such use of the host property not caused solely by the gross negligence or willful misconduct of Prime Party Rentals, LLC.

PROPERTY DAMAGE LIABILITY

Any and all property of Prime Party Rentals, LLC, shall be subject to inspection prior to removal of the property by Prime Party Rentals, LLC. Any and all property damage caused by the rental use of said property shall be the responsibility of the Lessee/User/Renter.

GOVERNING LAW AND JURISDICTION

This agreement shall be governed by the Laws of the State of Louisiana and the substantive laws of the State of Louisiana shall apply. The parties agree that this contractual agreement is deemed to have taken place in St. Francisville, Louisiana, Parish of West Feliciana, State of Louisiana. THIS AGREEMENT, consisting of two pages was read, acknowledged, and confirmed and agreed by all parties and was signed herein in the Parish of West Feliciana, State of Louisiana.
