Board Minutes

Meeting Date: January 15, 2020

The Elsinboro Planning Board re-organization meeting was held at 6:30 p.m. in the Emergency Management Building. Members present were Chairman Dave Faulhaber, Steve Cornman, Sean Elwell, Michael Khairzada, Kurt Kaufmann, Joe McAllister, Rich Kazunas, Bill McGowan III, Ken Brown, and Joe Robbins. There were no members of the public present for the meeting. Dave Faulhaber who then read the sunshine law statement opened the meeting. The Chairman started the meeting with a salute to flag.

Motion #1: Steve Cornman made a motion to appoint Dave Faulhaber as Chairman pro tempore. Rich Kazunas seconded the motion. The motion carried by a vote of 9 ayes, 0 nays, and 0 abstentions.

Motion #4: Joe McAllister made a motion to appoint Steve Cornman as Board Secretary for the year 2020. Mike Khairzada seconded the motion. The motion carried by a vote of 9 ayes, 0 nays, and 0 abstentions.

Motion #5: Steve Cornman made a motion to elect Rick Kazunas as Vice-Chairman for the year 2020. Sean Elwell seconded the motion. The motion carried by a vote of 9 ayes, 0 nays, and 0 abstentions.

Meeting Date: July 15, 2020

The Elsinboro Planning Board meeting was held at 6:30 p.m. This meeting was conducted via teleconference due to the Governor's Executive Order regarding the COVID-19 pandemic. Members present on the call were Chairman Dave Faulhaber, Steve Cornman, Sean Elwell, Frank Master, Kurt Kaufmann, Joe McAllister, Rich Kazunas, Bill McGowan III, and Joe Robbins. Also, on the call were Board Solicitor, Marla Gaglione, applicant Joe Winchell, and the applicant's attorney, Adam Telsey. There were no members of the public on the call for the meeting. Dave Faulhaber called the meeting to order and read the sunshine law statement.

The Chairman reviewed the guidelines for conduct of the meeting - Board members and professionals must state name prior to speaking and voting, all votes for this meeting will be roll call votes, public speakers must state their name and address prior to speaking, and when not speaking, participants should mute their phones.

Motion #1: Kurt Kaufmann made a motion to dispense with reading and approval of minutes of 1/15/20 meeting. Sean Elwell seconded the motion. The motion carried by a vote of 9 ayes, 0 nays, and 0 abstentions.

The Chairman then stated the purpose of the meeting – to review and act upon application 2020-01, submitted by Mr. Joe Winchell. The applicant is requesting approval of Bulk Variances to allow for the construction of a garage on Block 19, Lot 6.13. All materials submitted for this application were available for public inspection on the Township's web page.

Motion #2: Kurt Kaufmann to approve the following application submission waivers, Schedule A Item 6. Schedule C – Items 33, 41, 42, 43, and 44. Joe McAllister seconded the motion. The motion carried by a vote of 9 ayes, 0 nays, and 0 abstentions.

Motion #3: Sean Elwell to deem application complete as submitted. Joe McAllister seconded the motion. The motion carried by a vote of 9 ayes, 0 nays, and 0 abstentions.

The applicant was sworn in by the Board Solicitor and Adam Telsey presented the application to the Board, stating the purpose, variances requested, hardship necessitating variances, and why the granting of these variances is good for the community. Following the presentation of the application, the meeting was opened for Board member comments and questions.

Kurt Kaufmann asked about impervious surfaces. The applicant testified that concrete would be used. Dave Faulhaber and Sean Elwell asked if the building down spouts would be tied into the Locust Avenue drains? The applicant testified that the water would be directed to the drains but not physically tied in. Sean Elwell asked if the building would block the view of the river. The applicant testified that it would not block the view.

Motion #4: Kurt Kaufmann moved to open the meeting for public comment. Frank Master seconded the motion. The motion carried by a vote of 9 ayes, 0 nays, and 0 abstentions.
