Payment Methods

Streetline Performance & Accessories Inc. accepts the following forms of payment:

- **Major Credit Cards (Visa, MasterCard)**
- **Business Checks**
- **Personal Checks**
- **Certified Bank Checks**
- **Money Orders**
- **Wire Transfers**
- **Bitcoin**
- **XRP**

At this time, cash payments and C.O.D. (Cash on Delivery) orders are not accepted.

All payments must be made in U.S. Dollars (USD).

Streetline Performance & Accessories Inc. reserves the right to modify accepted payment methods at any time without prior notice.

Credit Card Payments

Customers placing orders online may pay using major credit cards, including Visa and MasterCard.

All credit card transactions are processed through secure encrypted payment systems designed to protect customer information.

By submitting credit card payment information, the customer:

- **Authorizes Streetline Performance & Accessories Inc. to charge the provided payment method**
- **Confirms they are the authorized cardholder or have permission to use the card**
- **Agrees to pay the full order amount, including taxes, shipping, and applicable fees**

Streetline Performance & Accessories Inc. reserves the right to request additional identity or payment verification for certain transactions in order to prevent fraud.

Orders may be delayed or cancelled if payment verification cannot be completed.

Check & Money Order Payments

Streetline Performance & Accessories Inc. accepts:

- **Personal checks**
- **Business checks**
- **Certified bank checks**
- **Money orders**

Personal and business checks must include the following information:

- **Name of the account holder**
- **Physical address (P.O. Box-only addresses are not accepted)**
- **Check number and bank imprint**

Customers may also be required to provide:

- **Current phone number**
- **Valid government-issued identification**

Orders paid by personal or business check will not be shipped until the payment has cleared the banking system, which may take 7–10 business days.

Streetline Performance & Accessories Inc. reserves the right to delay shipment until funds are fully verified and cleared by our financial institution.

Orders Over \$400

Orders totaling \$400.00 or more that are paid by check may require payment by one of the following methods:

- **Money Order**
- **Certified Bank Check**
- **Wire Transfer**

Streetline Performance & Accessories Inc. reserves the right to require secure payment methods for higher-value transactions.

Wire Transfers

Wire transfers may be accepted for certain orders.

Customers requesting to pay by wire transfer must contact Streetline Performance & Accessories Inc. directly to receive wire transfer instructions.

Any bank transfer fees or processing charges are the responsibility of the customer.

Orders will not be processed until the full payment amount has been received and confirmed.

Payment Verification

For security and fraud prevention purposes, Streetline Performance & Accessories Inc. reserves the right to:

- **Request additional verification documentation**
- **Verify billing and shipping information**
- **Delay or cancel orders suspected of fraudulent activity**

Failure to provide requested verification information may result in order cancellation.

Insufficient Funds & Returned Payments

If a payment is returned due to insufficient funds (NSF), closed accounts, or payment reversal, the customer may be subject to:

- **A returned payment fee**
- **Cancellation of the order**
- **Suspension of future purchasing privileges**

Streetline Performance & Accessories Inc. reserves the right to pursue collection of unpaid balances through appropriate legal or financial channels.

Order Balance Adjustments

If the payment submitted for an order is less than the total amount due, the customer will be notified and required to submit the remaining balance before the order can be processed.

Orders will not ship until full payment has been received.

Sales Tax

Customers are responsible for paying any applicable sales tax required by state or local regulations.

Sales tax will be applied in accordance with current tax laws and nexus requirements.

Authorized dealers with valid resale certificates may be exempt from sales tax where applicable.
