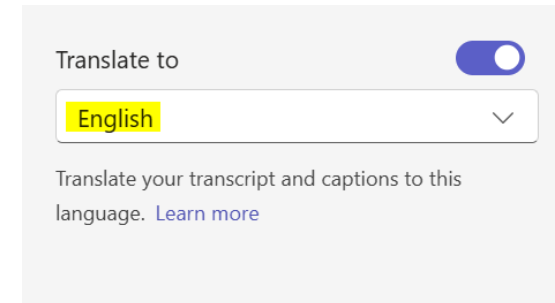
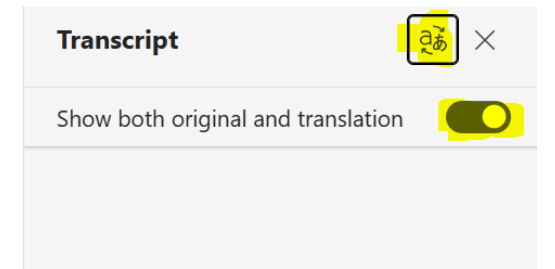
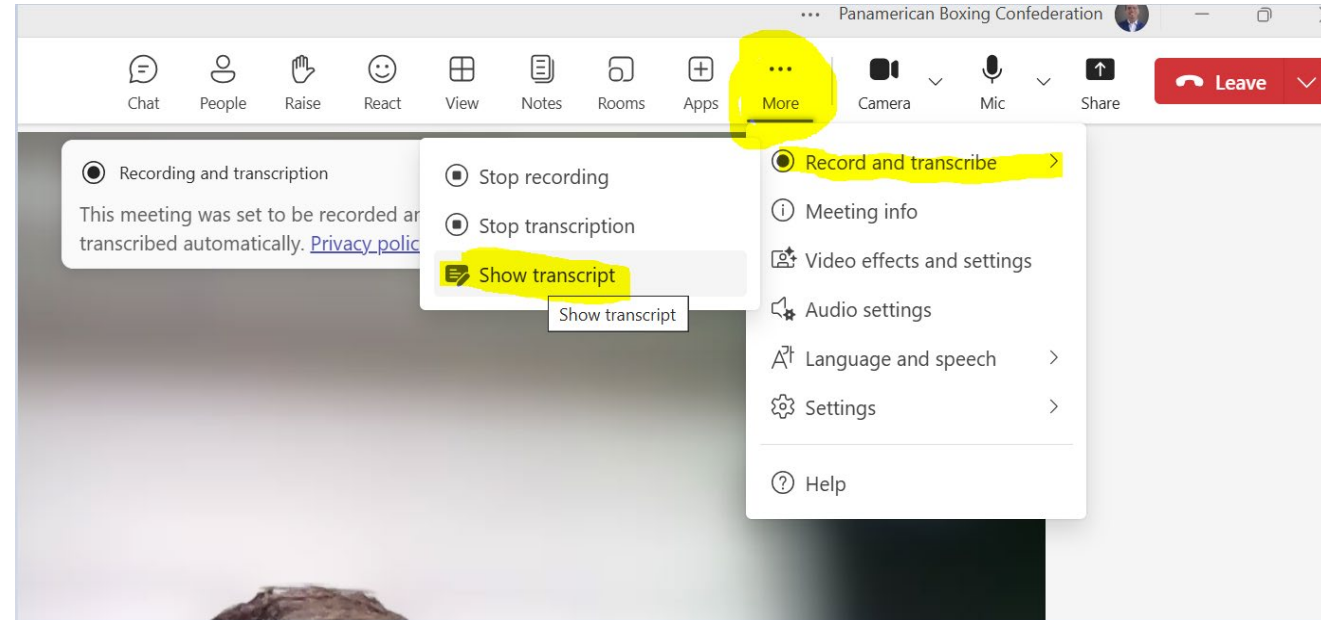

**Qualification System (QS) & Criteria** to be established by WORLD BOXING

**Qualification System Principles** (Approved by IOC 03/2025): **Clear and easy to comprehend** NOCs/NFs, athletes & coaches (no room for interpretation)

- Rules of **fair and equal opportunities** for all NOCs
- Qualification pathway, allocation process, reallocation process and timeline
- Must ensure participation of best athletes based on field of play **performances**
- Ensure continental representation, **use of continental multisport games should be prioritized**
- Ensure minimum number of universality places. Procedure to be published 02/2026
- Eligibility criteria (Age, technical requirements, anti-doping)
- Must contain timeline for qualification, cannot exceed 24 months
- **Sport entries deadline for LA28: Monday June 26<sup>th</sup> 2028**

## Qualification Events

- Direct qualification events & indirect ranking events to be announced by IF before start of qualification period and defined in QS.
- World Boxing **shall use existing events in calendar for qualification where possible**
- **Continental Multisport games encouraged to be used where possible**
- Qualifying events organized by IF or Confederation **MUST follow Olympic charter** (non discrimination respected)
- **All qualification events completed by Sunday June 11<sup>th</sup> 2028**

# Membership Update

- **Current Members: 19**, Pan American Sports requirement to be included: > 22 National Federations
- **Outstanding: 5** applications: **2 to be approved** by WB Board of Directors, **3 in process**
- **Swiss law of free association regarding boxers participating in events outside of World Boxing, however...**
- ❖ September 2024 IOC letter: *“The NOCs shall no longer affiliate, or entertain any institutional relationship with, national boxing federations that are still affiliated to IBA.”*
- ❖ World Boxing is evaluating and drafting procedures that follow the principle of the Olympic Charter that place the responsibility on the NOC’s
- In line with **Olympic values to promote inclusiveness, transparency** & continue working towards **full recognition** proposal to allow *passive* attendance from prospective Members.
- Members **must pay World Boxing annual dues** to be considered a member in good standing
