- Congratulations Ryan O'Shea reelected as Vice President



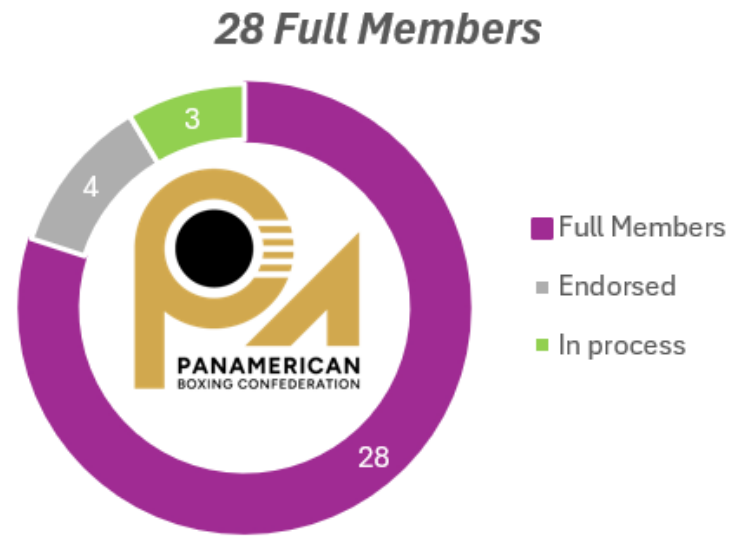
### WORLD BOXING LANSCAPE

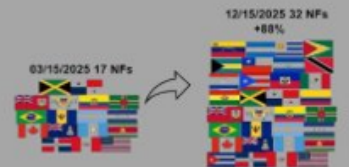

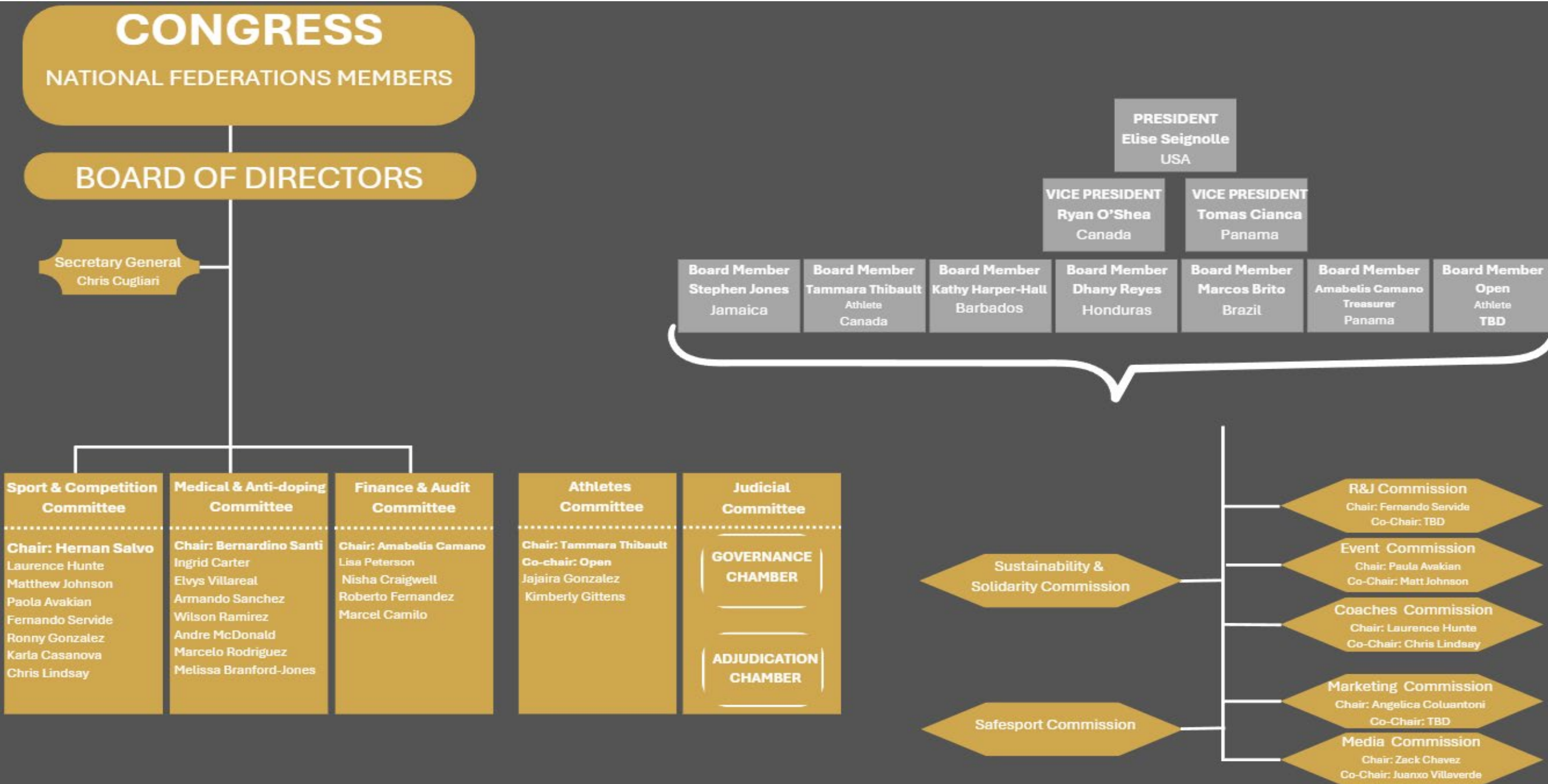

- Training camp in Mexico City prior to Guadalajara Central American & Caribbean Games Qualifier (possible R&J and Medical seminars)
- Reminder – mandatory compliance with World Boxing’s sex eligibility policy for ALL boxers 18+ years old starting January 1
- March – U19 Futures Cup is eligibility tournament for Youth Olympic Games (cannot be born before November 13, 2008)
- April – Youth South American Games (must be born between January 1, 2008 and December 31, 2009)

- Criteria for International Competitions to be endorsed by Panamerican Boxing Confederation:
  - Must comply with World Boxing Competition Rules – especially section 1.3 which deals with International Competitions (e.g., only open to World Boxing members)
  - Request must be communicated by National Federation to [competitions@panamericanboxing.org](mailto:competitions@panamericanboxing.org) and competition must be run by host National Federation
  - Handbook must be approved by Sport & Competition Committee 2 weeks prior to start of registration – send to [competitions@panamericanboxing.org](mailto:competitions@panamericanboxing.org)
  - Host federation must agree to allow an individual approved by Sport & Competition Committee to evaluate venue / setup prior to start of the event – PBC agrees to be very reasonable on this request

- R&J and ITO Registration with World Boxing
  - See December 1, 2025 email from [officials@worldboxing.org](mailto:officials@worldboxing.org)
  - Deadline is December 31, 2025 – candidates will then have eligibility checked / confirmed and educated with online modules
  - Continental level R&Js – must have participated in 1-3 international tournaments (>=5 NFs) since 2018
  - Other positions – Equipment Manager, R&J Coordinators, Technical Delegates

# Reminder – Athletes Committees

- As part of World Boxing provisional recognition by IOC, World Boxing demonstrated compliance with AIMS / SportAccord
- AIMS / SportAccord highlight need for National Federations to demonstrate strong governance with particular emphasis on Athlete Representation
  - This means our National Federations must include a functioning Athletes Committee – voice of the athlete represented on Board of Directors with voting rights!
- Chris has contacted those who have yet to comply – please provide evidence that this is included on agenda for next board meeting
