Submission Deliverables

- Compliance and due diligence checklist (KYC, AML, corporate approvals, filings, taxes - as applicable).
- Risk register with mitigations (fraud, conflicts, data, regulatory, litigation, recovery).
- Implementation plan (steps, timelines, responsibilities, dependencies).

Evaluation Criteria

- Legal accuracy and practical enforceability.
- Commercial feasibility and investor readiness.
- Completeness of risk controls (fraud prevention, documentation, approvals).
- Clarity, structure and professional presentation (Big-4 style).



- Originality and strength of the idea.

Eligibility

- Advocates / lawyers / legal consultants (India or global) with corporate, finance, banking, compliance or litigation experience.
- Ability to deliver original work; plagiarism or copied templates will be disqualified.
- Must comply with confidentiality and professional ethics. No client-identifiable data.

Submission Method

- Submit through the online portal only.
- Upload: PDF + editable file (DOCX) for the main submission.
- Optional: 3-5 minute pitch video (link) or 5-slide deck (PDF).

Selection Process (High Level)

- Application and upload on portal
- Eligibility screening
- Jury evaluation
- Final shortlisting and verification
- Announcement and onboarding communication
