



STARTING YOUR MOBILE MECHANIC BUSINESS ON PITSTOPR

STEP 1: Operate as an Independent Business

Technicians on PitStopr operate as independent contractors, not employees. You are responsible for running your own business.

Most technicians operate as:

Sole Proprietors (simplest setup)

Single-Member LLCs (commonly used for liability protection)

ACCEPT PAYMENTS AND MAINTAIN
BASIC BUSINESS RECORDS.**

How to get set up:

Sole Proprietor:

You may not need to file formally, depending on your state. Some technicians register a DBA (Doing Business As).

LLC:

File through your state's Secretary of State website. This can usually be completed online in under 30 minutes. Fees vary by state.

STEP 2: Required Insurance Coverage

To operate on PitStopr, technicians **must carry their own insurance.**

Required policies:

General Liability Insurance

Covers bodily injury or property damage related to your work.

Garagekeepers Insurance

Covers damage to a customer's vehicle while it is in your care, custody, or control.

BOTH POLICIES ARE REQUIRED TO PROTECT YOU, YOUR CUSTOMERS, AND THE PLATFORM.

How to obtain coverage:

Search for “mobile mechanic general liability and garagekeepers insurance”

Many technicians obtain coverage through:

- Small business insurance marketplaces
- Commercial auto or trade-specific insurers

Policies are often available within 24–48 hours and billed monthly

MINIMUM COVERAGE AMOUNTS AND DOCUMENTATION ARE REVIEWED DURING ONBOARDING.

STEP 3: Taxes & Business Compliance

As an independent business, you are responsible for complying with applicable tax and licensing laws.

This may include:

Reporting income earned through PitStopr

Paying self-employment or business taxes

Understanding sales tax requirements in your state

Sales tax considerations:

Some states require sales tax on labor

Some require tax on parts only

Some exempt certain automotive services

Some require exemption certificates or registration

How to research your state's rules:

Visit your state's Department of Revenue website

Search: "Does my state charge sales tax on auto repair labor?"

Look for guidance on:

- Registration requirements
- Exemption certificates
- Filing and remittance schedules

Technicians operating on PitStopr are expected to:



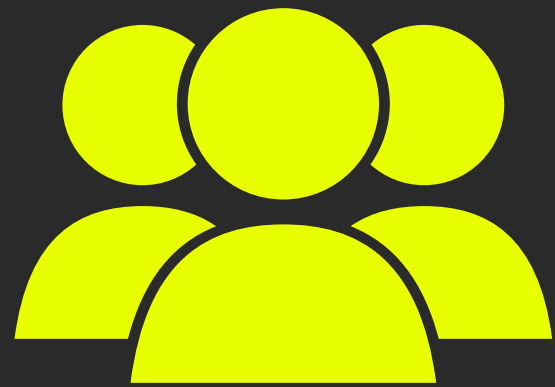
Communicate professionally with customers
