- **Pricing:** Any pricing discussed during the initial inquiry is an estimate based on the project scope and material costs at that time. Formal pricing will be provided directly to you via email before any work begins.

5. Design Proofs & Approvals

For custom or personalized orders, a digital design proof will be provided via email before production. It is the customer's responsibility to thoroughly check all spelling, grammar, layout, design placement, and color choices. Once you

reply with your final approval, the design is locked, and any post-production changes or corrections due to a customer-approved oversight will incur a remake fee.

6. Customer-Supplied Items

If you request customization on a blank garment or item that you provide, you acknowledge that industrial textile machinery and heat presses carry inherent structural risks. While I take the utmost care with your items, Evolution Embroidery & Crafts is not liable for replacing or reimbursing the cost of customer-supplied goods in the rare event of a machine, needle, or technical error.

7. Order Fulfillment & Payments
