## Compensation Model Small Projects (150K up 999K USD)

Commission: 5% fixed

Payment: 50% upon Bank  
Financial Approval &  
Contract signing

50% upon financial close



## Compensation Model Medium Projects (1M. up 9.9M USD)

5% on first 1M

3% on remaining amount

Payment: 40% from 1<sup>st</sup>  
tranche of the financial

40% close, 20%

Bonus for <45-day closes



## Compensation Model Large Projects (10M + \$USD)

3% on first 5M

2% on remaining amount

Payment: 30% from 1<sup>st</sup> tranche  
of the financial

50% close financial

20% Performance Bonus >25M



# Commission Eligibility

Commission is earned when:

- 1) Project accepted for onboarding
- 2) Client signs structuring agreement
- 3) Financial close is completed
