1. Acknowledgment of Risk

I, the undersigned, acknowledge that riding a motorized vehicle such as a scooter or motorcycle involves **inherent risks**, including but not limited to:

- Collision with vehicles, objects, pedestrians, or animals
- Mechanical failure or loss of control
- Road conditions, weather, and traffic
- Injury or death caused by my own actions, the actions of others, or unforeseen events

I certify that I am physically and mentally capable of operating a motorized vehicle and will not ride under the influence of alcohol, drugs, or any substance impairing my judgment.

2. Assumption of Responsibility

I voluntarily assume **full responsibility** for any risks of personal injury, property damage, or death, **whether foreseen or unforeseen**, that may occur during or as a result of my participation in any Tokyo Rides activities.

3. Waiver of Liability

I waive, release, and discharge **Vanish 404, its owners, staff, agents, sponsors, and affiliates** from any and all claims or causes of action, including those based on **negligence**, that may arise from participation in this activity.

This release extends to any claims arising **during the activity, while preparing, in transit, or after completion**.

4. Indemnity Agreement

I agree to **indemnify and hold harmless** Vanish 404 from any and all claims, lawsuits, losses, liabilities, damages, or expenses (including attorney's fees) brought against them by any third party due to my actions.

5. Legal and Insurance Notice

I understand that Tokyo Rides provides **basic liability coverage only**, and I am personally responsible for any medical expenses, injuries, or damage not covered by this policy. I have been advised to secure my own travel or accident insurance if needed.

I agree that any disputes shall be resolved under **Japanese law** in the **Tokyo District Court**.

6. Equipment Condition & Responsibility

I agree to treat the provided motorcycle/scooter, helmet, and other equipment with care. I will be financially responsible for any **intentional damage, negligence, or theft** of the gear entrusted to me.

7. Media Release

I grant Vanish 404 the right to use any **photos, videos, or testimonials** taken during the ride for promotional and marketing purposes without compensation or further permission.
