- c) I am the owner of record of the homestead for which I am seeking a property tax freeze, or have legal or equitable interest in such property by written instrument.
- d) I am liable for the payment of real property taxes on such homestead, and current taxes are paid in full.
- e) I occupy the homestead as my primary residence for which I am seeking the Cole County Senior Real Estate Property Tax Freeze credit.

I understand I may be charged with a Class A misdemeanor as stated in Section 575.050 RSMo if any information submitted in this application is found to be a false declaration. I am not aware of any information that would prohibit or disqualify me from receiving the tax credit for the homestead identified in this Application.
