

RESOLUTION 2024-02

A RESOLUTION AUTHORIZING THE MAYOR AND FISCAL OFFICER TO ENTER INTO AN AGREEMENT WITH JIM JASPER TO SERVE AS MAINTENANCE SUPERVISOR FOR THE VILLAGE OF ALEXANDRIA.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE VILLAGE OF ALEXANDRIA, COUNTY OF LICKING, STATE OF OHIO, THAT:

SECTION 1. The Mayor and the Fiscal Officer be, and they hereby are, authorized and directed to enter into an agreement with Jim Jasper to serve as Maintenance Supervisor for the Village of Alexandria, Ohio, a copy of which agreement is attached hereto as Exhibit "A" and incorporated herein fully as if by reference.

SECTION 2. The hourly rate of pay for Jim Jasper as Maintenance Supervisor, which shall be set on a calendar year basis by the Mayor and the Fiscal Officer, shall be between \$18-\$25/hour.

AGREEMENT

THIS AGREEMENT, made at Licking County, Ohio, this ____ day of 2024, by and between the VILLAGE OF ALEXANDRIA, 4 West Main Street, Alexandria, Ohio 43001 (hereinafter the "Village") and Jim Jasper ("Jasper"):

WHEREAS, the Village of Alexandria wishes to engage the services of Jasper as a Maintenance Supervisor; and

WHEREAS, Jasper is willing to serve as Maintenance Supervisor for the Village of Alexandria, Ohio, under the terms and conditions set forth herein.

NOW, THEREFORE, IT IS HEREBY AGREED between the Village and Jasper as follows:

1. The Village of Alexandria hereby hires Jasper to serve as Maintenance Supervisor for the Village of Alexandria, Ohio. Jasper shall perform such duties as assigned, and will provide twenty-four (24) hours of work time per week.
2. Jasper shall be an employee of the Village and shall be paid \$20.00 per hour.
3. This Agreement will continue to run and be binding on the parties for a period of one (1) year from the date hereof. This Agreement may not be modified in any manner except by the written consent of the Village and Jasper. This Agreement may not be assigned by either party.
4. Either party may terminate this Agreement by giving the other party thirty (30) days prior written notice.
